I invite kind attention to the reference 1st cited where in it was requested to take necessary action on the representation of the General Manager, SCCL, Yellandu filed on 16.02.2020 on the clarification of land of 45 Ha. in Sy.No.588 pertains to Rompaid Village of Yellandu Mandal is Covt.Land or Forest land and whether it is a Reverse Forest.

In this regard, I have addressed a letter to Forest Range Officer, Yellandu vide reference 4rth cited to clarify whether the proposed land 45 Ha. in Sy.No.588 of Rompaid Village existing the Timber Depot belongs to Forest department and the Forest Range Officer, Yellandu has informed that the 45 Ha. Area existed in Sy.No.588 is located in Reserve Forest Area of yellandu extension Block-I and the Government Timber Depot, yellandu is also existed in the same Area. Already boundary pillars existed in the area, which was laid out during the period of approximately 1970's.

Further, I requested the Divisional Forest Officer, Kothagudem vide reference 5th cited to supply a copy of Forest Gazette for Sy.No.588 to an extent of 45 Ha. of Rompald village of Yellandu Mandal for taking further action. In this regard, the Divisional Forest Officer, Kothagudem has also instructed to the Forest Range Officer. Yellandu to, supply the Forest Gazette copy of the Sy.No.588 pertains to Rompaid Village.

Accordingly, the Forest Range Officer, Yellandu has submitted a copy of Reserve Forest block Gazette of the Sy,No.588 & Google earth imaginary map and informed that the Yellandu Reserve Forest block is notified under section 18 of Forest Act for an

extent of 30512.31 Acres vide Go.No.834, dt18.09.1354 Fasli and also published in the state Gazette no.39 dt:10.10.1354 fasli. The area of sy.No.588 of 45 Ha Rompaid village of Yellandu mandal is included in Reserve forest block and boundaries of this RF block shown in the field with existing old cairns around the said 45 Ha area and detail explanation given in the Reserve forest block Gazette description.

In this regard, the joint inspection was conducted comprising with the surveyor Girdawar-II, Forest Range officer, Yellandu & this office staff and estate officer of SCCL and their staff on 12.10.2020 and all the team was verified the land in subject and the Revenue team of surveyor & Girdawar-II has reported that the land covering the Forest timber Depot is belonging to Forest Department & Reserve Forest as per Gazette supplied by the Forest Department, pillars of Forest & other revenue records.

Therefore, as per report of Forest Range officer, Yellandu & Mandal Surveyor and Mandal Girdawar-II, Yellandu it is to submit that that the land of 45 Ha. in Sy.No.588 of Rompaid Village in the Reserve Forest Block and the Timber Depois belongs to Forest department is also part and parcel of the 45 Ha. in Sy.no.588 of Rompaid Village.

Hence, this is submitted for information and taking further action.
