

Joint Inspection Report

A Joint Inspection for the proposed site of Kandha SHP 0.40 MW of Bhagwati Hydro Power Project (OPC) Pvt. Ltd. C/o Mohan Singh Negi Village Mumale P.O. & Tehsil Karsog Distt. Mandi (H.P.) was conducted by the officers/officials of Govt. Departments dated on 20/02/2021.

Date of Inspection 20-02-2021

Bhagwati Hydro Power Project (OPC) Pvt. Ltd. (Kandha SHP 0.40 MW) is located between Elevation 1065 mtr. to Elevation 1040 mtr. on Kandha/ Karsog stream in Distt. Mandi Himachal Pradesh which is a tributary of Satluj River. The (Kandha SHP 0.40 MW) Bhagwati Hydro Power Project (OPC) Pvt. Ltd. is a run of the Kao Khad /river scheme for 0.40 MW Power generation. Kandha/ Karsog stream.

During the joint inspection, forest land 0.74 hectare in the jurisdiction of forest Division Karsog of Distt. Mandi Himachal Pradesh, proposed to be diverted is barest minimum Detailed inspection components wise, weir site, desilting tank, fore bay, water conductor system, transmission line, power house, switch yard, dumping site and power house of the proposed project sit was inspected and following points were discussed:-

- The proposed alternative was discussed and minimum use of forest land to be used in the project in Muhal Kandha and Pichhala Chera in Tehsil Karsog Distt, Mandi (H.P.).
- No archaeological monuments or defense establishment are located and involved near the proposed site of the project.
- It was examined that there is no danger to rare and endangered species of flora & fauna involved in the identified forest land area and nearby.
- On the basis of said inspection, it is certified that the 0.74 hectare Forest land proposed to be diverted is inescapable and other alternative for the proposed SHP have been explored and the forest land proposed to be diverted is barest minimum. The diversion of proposed forest land will not affect any burial ground, public utility or public water source (spring) etc. Therefore, the above land is recommended for the said purpose Forest Land proposed to be diverted for the proposed SHP Bhagwati Hydro Power Project (OPC) Pvt. Ltd. 0.40 MW.
