


Sir,



Therefore, it is requested to approach the revenue department for joint exercise in the field so that the status of the land be cleared and the further proceeding of the said FCA case be initiated.





Sir,

With reference to the subject cited above and the letter under reference, it is intimated that, as reported by the Range Officer, Dudu vide his letter No.196-98/RD dated 20.08.2020, during the course of joint survey exercise involving your representatives in the Project, "Chenani-Sudhmahadev Road from Km 2+250 to 3+450 and from Km 10+100 to 10+560, National Highway (NH-244)", the status of land at two locations is not clear and have objections from Revenue Department, so to complete the joint survey exercise which is essential for further processing the case for diversion of forest land under FCA act, it requires a joint demarcation exercise from Revenue and forest department. As such, Range Officer, Dudu has been directed to communicate the Revenue Authorities in this matter. You are also requested to approach the Revenue Department for conducting joint exercise in the field at the earliest.


Moreover, as per your request, forest diversion area for FRA Certificate will be communicated as and when, the joint survey will be completed on the field.

Further, Range Officer, Dudu vide his letter No. 199-201/RD dated 21.08.2020 has also communicated to your office that the details submitted by you in Indent/ Proposal for diversion of forest land have many discrepancies and some of them have not been found correct in the field, as the RD positions and some maps are not correct. Due to which, Range Officer is not in a position to complete the exercise. Therefore, you are requested to depute the concerned representative of your department to clarify the same in the field at the earliest for further perusal in the matter.
