ii.	Item No. A 2(i) User Agency has not mentioned Name of User Agency which is mandatory.	Name of user Agency "PMU Agartala" has been mentioned. This project is being implemented by the PMU Agartala, therefore, the same is the user agency. Further this column is non-editable in the online form. Hence, cannot be changed.
iii.	Item No. B (ii) U.A has not mentioned list of proposals already submitted in the past.	The details of proposals already submitted in the past has been mentioned.
iv	Item No. B.2.4 U. A has to mention CS plot No. & Khaitan No. Against component wise break up column.	CS Plot No. & details have been mentioned against component wise break up column.
v.	Item No. C (ii) (b) (1.2.3) U. A has noted attached KML files but not found in the software.	KML file has been reattached. Even if the same is not available it can be provided separately if required.
vi.	Item No., C (iii) U.A has noted attached Survey of India Toposheet but not demarcated proposed area over the map and also not shown legend of the proposed area.	Revised survey of India Toposheet has been uploaded
vii.	Item NO. C(iv) U.A has noted attached scanned copy of Geo-referenced map but not as per requirement which are to be prepared by using GPS or total stations.	Revised Geo-referenced map prepared by Total station has been uploaded.
viii.	Item No. L(i) to (iii) U.A has to submit the reason for not providing no-forest land for raising CA.	Item no. L(i) to (iii) are non-editable in on line form. Therefore, details cannot be provided. This is a Govt. Of India Project, therefore, providing non-forest land for raising CA is not applicable to this project.
ix.	Signature of the U. A is required on the form.	Signed form is being submitted with this letter.
