Sub: NOC Case for proposed MS/HSD retail outlet Dealership at location MDR 118 (Within 15 Km. of Guru Brahamanand Chowk (Pundri Chowk) on Pundri Rajound road towards Rajound) Kaithal District Haryana Category OBC (DC Rural)


Ref:- Your office Endst No. 2713/22/LPA dated 02.09.2015. *relates to S & PWD B & R Deptt*

In this connection it is intimated that this office has no objection for proposed construction of approach road for the above cited subject. This NOC will be subjected to following condition: -

1. That no pucca structure will be constructed within the PWD land boundary.
2. That the natural profile of road land width will not be disturbed on account of this proposed construction.
3. The proper Culvert/H.P. Culvert will be provided by owner on the approaches at his own cost for cross drainage of water.
4. There should be no inconvenience to the traffic with the installation of this proposed Petrol Pump.
5. Drainage/Rain water from Petrol Pump should not come on the PWD road/ land.
6. The access of Petrol Pump will be only through service road. No direct access on the road will be allowed. The cost of this service road will be borne by the owner of the Petrol Pump.
7. Separate NOC from Forest department is to be ascertained by the Petrol Pump owner.
8. There should be no Petrol Pump with in 300 Metre from the given RD of proposed Petrol Pump.
9. The instructions for opening retail outlet as prescribed by IRC, 2009 will be strictly followed ¹²⁻
10. The floor level of pump will be kept 9" down than the finished existing PWD road level.

11. The proposed RD of Petrol Pump should not be within 300 metres of T-Junction or X-junctions of the road.
12. If any of the condition is found violated in future the NOC will be withdrawn straightway & encroachment will be demolished
13. Lease money will be deposited as per Engineer-in-Chief, Haryana PWD B&R, Chandigarh letter No. 4964-5033/General dated 23.06.2011


