In Compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11 - 9/98- FC (pt.) dated 3 rd August 2009 where in the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the **Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006** ('FRA', for short) on the forest land proposed to be diverted for non - forest purposes. it is certified that 101.00 Hectare of forest land proposed to be diverted in favor of Executive Engineer Water Resources Division Khandwa (M.P.) for construction of **Bham Medium Project for irrigation purpose** in **Khandwa district** falls within jurisdiction of **Handiya kheda village 21.10 hectare in khandwa tehsil and Sarmeshwar village 79.90 hectare in Khalwa tehsil.**

It is further certified that:

(a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 101.00 hectares of forest land proposed for diversion. A copy of records of all consultation and meetings of the Forest Rights Committee(s), Gram Sabha, **Handiya kheda Gram Panchayat**, and **Sarmeshwar Gram Panchayat** Sub - Division Level Committee Pandhana, Sub - Division Level Committee Khalwa and the District Level Committee Khandwa are Enclosed as annexure 1 to 6.

(b) The proposal for such diversion (with full details of the project and its implications in vernacular / local language) have been placed before each concerned Gram sabha of forest dwellers, who are eligible under the FRA.


(c) The each of concerned Gram sabha(s), has certified that all formalities / processes under the FRA have been carried out, and that they have given their consent to the proposed diversion and the compensation and ameliorative measures, if any, having understood the purpose and details of proposed diversion. A copy of certificate issued by the Handiya kheda and sarmeshwar Panchayat Gramsabha is enclosed as annexure 1 and 2.

(d) The discussion and decisions on such proposals had taken pace only when there was a quorum of minimum 50 % of the members of Gram sabha present.

(e) The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Gram Sabhas have given their consent to it.

(f) The rights of primitive Tribal Groups and Pre-Agricultures communities, where applicable have been specifically safeguarded as per section 3 (1) of the FRA.
