

Sub: Grant of Mining Lease for Iron ore in favour of M/s Ghanashyam Misra & Sons Pvt. Ltd., the successful bidder in respect of Gorumahisani Iron Ore Block over an area of 348.049 ha (as per DGPS) / 349.500 ha (as per ROR) in village Kuleisila, Badamouda, Sanamouda, Sundhal, Balitangiri, Nodhabani and Gorumahisani RF under Rairangpur Tahasil of Mayurbhanj District.

Whereas in pursuance to the "Invitation of bids for grant of Mining Lease for Iron ore" dated 06.12.2019, issued by the Government and subsequent auction held on dated 10.02.2020, M/s Ghanashyam Misra & Sons Pvt. Ltd., has been declared as the preferred bidder for grant of Mining Lease of Gorumahisani Iron Ore Block in Mayurbhanj District;

And whereas the preferred bidder has made payment of first instalment of the upfront payment and subsequent to this, it has been issued with a Letter of Intent vide letter No. 3019/SM dated 18.03.2020 for grant of mining lease followed with the Vesting Order vide order No. 4517/SM dated 04.06.2020;

And whereas on the request of the preferred bidder, extension of time by a period of 15 (fifteen) days has been granted under the proviso to sub-rule (6B) of rule 10 of the Mineral (Auction) Rules, 2015 (herein after referred as the said rules) vide letter No. 4998/SM dated 12.06.2020 for complying with all the requirements to execute the mining lease deed;

And whereas, on payment of second instalment of the upfront payment, submission of the performance security and complying with all other requirements as prescribed under rule 10, sub-rule (3) of the said rules, M/s M/s Ghanashyam Misra & Sons Pvt. Ltd., has been declared as the successful bidder vide order No.5639/SM, dated 01.07.2020;

And whereas, under sub-rules (4) and (5) of rule 10 of the said rules, the successful bidder has signed the Mine Development and Production Agreement with Collector, Mayurbhanj district on dated 02.07.2020 and has paid the third instalment of upfront payment as reported by the Director of Mines vide his letter No.4629/DM dated 02.07.2020.

Now, therefore, State Government, after careful consideration, in exercise of powers conferred under rule 10, sub-rule (5) of the Mineral (Auction) Rules, 2015 have been pleased to grant the mining lease for Iron ore in favour of M/s Ghanashyam Misra & Sons Pvt.
