I(i) Whether the project or a part thereof is located in any Protected Area or their Eco Sensitive Zone?	Proposed area falls is at approximately 5.94 Km from Gudekote Sloth Bear Sanctuary. Accordingly, you are advised to contact jurisdictional Deputy Conservator of Forests for obtaining clarification whether the project falls within the Eco Sensitive Zone Limits of the sanctuary. If so, the project will require permission from the Jurisdictional ESZ Monitoring Committee in connection with taking mitigation measures.	As suggested we have approached the DCF, Bellary for Clarification. As it will consume considerable amount of time, we undertake that the clarification certificate will be furnished very shortly before Stage-I clearance. However as per the ESZ boundary map Published vide MoEF&CC Notification S.O. no. 2145 (E) dated 06.07.2017, The nearest point of ESZ Boundary (Map ID no. 35) is at a distance of 1.9 Km from the Project Alignment clearly showing not falling in the ESZ Boundary and not requiring any clearance from the ESZ boundary map showing the project alignment outside the boundary is herewith enclosed for your kind reference.
General	Please ensure that the forest extent figures shown in different items tally with KML file as well as GPS points.	Yes, We made sure that the forest extent figures are tally with KML as well as GPS points. But it is also requested to oversee the negligible error which would be due to change of software used for calculation.

- 2. Undertaking for Payment of Compensatory Afforestation Cost
