	2	The State Govt. in Part-II form mentioned the Canopy density of the proposed forest land for renewal of lease as Nil whereas good vegetation cover is visible through satellite imagery in the proposed land. Also the CCF in its site inspection report has mentioned that 45 no. of trees are marked for felling. This needs clarification and the factual position needs submission.	MoEF Order F.No. 8-123/2003-FC dated 08.11.2005 for years. During this diversion period a safety zone of 2.1 Ha had been kept as per the condition no.vi. Due to the reason good vegetation cover is present over the safety zone area of the 80.77 Ha forest land. Other than the mining activities have been stopped since October 201 so as bushes and other vegetations are came up on the benches of the 80.77 Ha forest land. It can be verified

Part II was prepared on the basis of the field visit dated 06.04.2018 in which Canopy density was mentioned as NIL. However, during the Site Inspection held on 24.12.2018, trees found in the Safety Zone of 80.77 Ha were counted for felling and reported in the Site Inspection Report dated 26.02.2019. As per the site		

inspection report dated 26.02.2019, the Canopy Density was given as 0.1 (Eco-Value Class III). Species-wise list of trees to be felled also given in Online Part II in which 45 number of different trees and 48 number of Bamboo was given. Copy of the Online Part II and Revised Site Inspection Report of DFO-Chandrapur Forest Division enclosed as Annexure II.

- b. As per the Site Inspection Report of Chief Conservator of Forests, Chandrapur Circle dated 10.01.2019, 27 number of trees below girth size 60 cm, 18 number of trees with more than 60 cm girth size and 48 number of Bamboo totaled up to 93 trees are proposed for felling. Copy of Site Inspection Report of CCF-Chandrapur Circle enclosed as Annexure III.
- c. It is pertinent to mention here that in Site Inspection Report DFO dtd. 27th March 2024 it is categorically mentioned that there are 45 different trees & 48 Bamboos in the proposed area. Copy of the Site Inspection Report and Details of trees enclosed as Annexure IV.

The mining plan for 80.77 ha forest land for renewal submitted with the proposal is of year 2007. Therefore, the validity and the relevance of the same shall be examined and revised and updated mining plan along with progressive mine closure plan shall be submitted accordingly. The state shall also ensure that the land use plan / component wise breakup of the area in the proposal is commensurate with the approved mining plan. A comparative analysis of the same shall also be submitted.

It is herewith submitted that the land use pattern of subject 80.77 Ha Forest land is not affected / changed due to the revision of mining plan for expansion of mine. The renewal of forest clearance of 80.77 Ha Forest land was submitted based on the approved Mining Plan of 29th May 2007. Later, it was revised in 21st February 2017. The proposed 80.77 Ha was proposed for coal extraction and reclamation in both of these Mining Plans.

Land Use Plan / Component wise break-up of the area in the proposal i.e., 80.77 Ha is same with approved mining plan.

As per the above comparative analysis, total area of the project in 2007 is 1598.22 Ha including the 411.68 Ha additional land is proposed for acquisition. Later, 410.96 Ha acquired u/s 9(i) of CBA (A&D) 1957 vide SO No.2922 dated 25.11.2010 which makes the total area of the project as 1597.50 Ha. Hence, there is no changes in the usage of 80.77 Ha Forest land due to revision of Mining Plan. (Copy of Board Approval of Revised Project Report and Progressive Mine Closure Plan is enclosed as Annexure V and Revised Mining Plan is enclosed herewith as Separate Booklet as requested).

		2. Electricity is being supplied by the Maharashtra State Electricity Distribution Company Limited (MAHADISCOM) to WCL. Water requirement for the project is being met through Mine Water which is utilized for industrial as well as domestic needs of the project. The project has obtained NOC from Central Ground Water Authority for the same. (Copy of the NOC from CGWA enclosed as Annexure X)
9	The user agency has informed that the 80.77 ha forest land in the instant proposal will be utilized for dumping of overburden removed from the approved forest area of 121.58 ha forest land. However, reason behind such non-site-specific utilization of proposed forest land under renewal has not been given. Further, instead of just furnishing mining, complete component details of the proposed forest land shall be updated in the Part-I form along with component wise KML file/ maps needs submission.	As per Part I submitted along with the proposal, it is clearly stated that the 80.77 Ha Forest Land is required for Mining Operation for Extraction of Coal. As per the revised mining plan also 80.77 Ha Forest Land will not be used for dumping of overburden removed from the approved forest land area of 121.58 Ha. Instead, 80.77 Ha will be used for coal mining and reclamation. At present, approximately 46.10 Ha area out of 80.77 Ha is bearing coal. This area will be used for Coal Extraction and remaining area will be used for movement of men, machineries and other mining operations. At the end of mining operations, 80.77 Ha will be reclaimed as per the approved mining plan. Complete component details of the proposed forest are updated in Part I. 11	It is observed that the user agency is obtaining the approvals under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 of the forest land within the lease in piecemeal manner. It can be clarified vide the clarification issued by the Ministry of Coal vide letter F.No.43015/28/2017-LAIR (Vol.II) dated 11th December 2019,

The State Govt. shall inform whether the approval of safety zone has been obtained or otherwise.

80.77 Ha Forest land was diverted vide MoEF letter 8-123/2003-FC dated 08.11.2005. During this diversion as per the MoEF guideline and directives of the State Forest Department 2.63 Ha area all along the Forest Land was kept as safety zone within the 80.77 Ha Forest Land.

As per the Stage I Condition No.iii issued by the MoEF, New Delhi vide letter no. 8-123/2003-FC dated 27.04.2004, "The User Agency shall raise and maintain a safety zone (including fencing, regeneration etc), taking

		7.5 meters strip of the forest land all along the oute boundary of the mining lease area at the project cost. WCL has complied the condition by erecting pillars and maintaining the 7.5 Meters all along the 80.77 Ha Fores land admeasuring an area of 2.63 Ha. Remaining 78.1 Ha only used for mining purpose.
