*After detailed discussion on various aspects of the proposal, the REC decided to reject the proposal.*

**Agenda Item No. 06:** Diversion of 5.1775 ha of forest land for construction of Dunda-Kurha motor road to Jakhari-Balla motor road in favour of PWD within the jurisdiction of Uttarkashi Forest Division District Uttarkashi, Uttarakhand (Online Proposal No. FP/UK/ROAD/28906/2017).

Regional Empowered Committee discussed the proposal seeking diversion of 5.1775 ha of forest land for construction of Dunda-Kurha motor road to Jakhari-Balla motor road. The committee noted that 912 trees are proposed to be felled in the project. The forest land proposed for diversion is not a part of any Protected Area and no rare and endangered species of flora and fauna have been reported in the area proposed for diversion. Further, no violation of FCA has been reported by the State Government. The User Agency briefed about the proposal before the committee.

*After detailed discussion on various aspects of the proposal, the REC is of view that the revised proposal may be submitted up to village 'Olva' only i.e. point no. 11 of geo referenced digital map, (Longitude-78°20'21.979"E, Latitude- 30°42'30.369"N) as the proposed road beyond that point is not justified.*

**Agenda Item No. 07:** Diversion of 0.156 ha of forest land for construction of Gangi Small Hydro Electric Project (200 KW) in favour of Uttarakhand Renewable Energy Development Agency within the jurisdiction of Tehri, New Tehri Forest Division, District Tehri Garhwal, Uttarakhand (Online Proposal No. FP/UK/HYD/32329/2018).

Regional Empowered Committee discussed the proposal seeking diversion of 0.156 ha of forest land for construction of Gangi Small Hydro Electric Project (200 KW). The committee noted that in total there are 12 trees proposed to be felled in the project. The forest land proposed for diversion is not a part of any Protected Area and no rare and endangered species of flora and fauna have been reported in the area proposed for diversion. Further, no violation of FCA has been reported by the State Government.
