i)	As per the DSS analysis, it is found that alignments of the uploaded KML file of the three divisions do not match with each other and also are not congruent with the installed towers (apparently installed over forest land in violation of FCA). Therefore, it may be re-examined and correct KML file may be uploaded.	It is submitted that reassessment of the forest area along the route of the line in all 3 divisions has been done and the KML file along with maps has been duly checked by respective Forest Divisions. The same has been uploaded in PARIVESH.
ii)	The total no of trees enumerated in forest land proposed for diversion is 15354 but conventionally they all would not require felling. Therefore, number of trees proposed for felling, trimming and translocation may be informed.	Tree enumeration for the forest area has been done, verified and certified by respective FDs with respect to number of trees proposed for felling, trimming and translocation. Details are mentioned in jointly signed tree enumeration list of the respective FDs.
iii)	The CA scheme (with 10 years of maintenance) provided under Latehar FD has not been uploaded on the online application. Also, around 60Ha of forest proposed for CA are already high on vegetative index, therefore, appropriate area should be identified for the purpose.	Revised CA scheme for Latehar FD has been uploaded by DFO, Latehar on 26.09.2025.
iv)	The alternative routes of transmission line are not legible, the kml of these routes too may be submitted.	Detailed Alternate Route Analysis and Alternate Routes on Sol topo have been uploaded and submitted. KML files of Alt. Routes also submitted to all the FDs in CD.
v)	As per online application, total temporary employment is 600000 whereas total employment mention in Cost Benefit (CB) analysis is 120000. It may be clarified. Also, the rates eg. NPV, daily wage etc. taken for CB estimation is old, present rate may be incorporated to assess the CB Ratio.	Revised Cost Benefit analysis has been uploaded and Employment Generation has also been revised in Part-I of the Proposal.
vi)	As per DSS analysis, it appears that the proposed forest land for diversion has been violated by User Agency. But only Latehar forest division has reported violations whereas apparently the violation has also happened in Ramgarh & Ranchi Forest Division which requires filed verification. If, violation is done, then it must be taken into cognizance at the earliest and a complete action taken report against the perpetrators in this regard may be uploaded/submitted to this office along with the explanation of why forest department could not assess the violation (Ramgarh & Ranchi FD) while processing the application. Therefore, fresh site inspection report by the concerned DFOs become imperative.	Taken up with respective Forest Divisions at the time of Part II formulation.
