

MEMORANDUM

The undersigned presents compliments to the Nodal Officer, Maharashtra State, Nagpur with reference to the correspondence resting with his letter No.D-17/NC/II/2053/1999-2000, dated 4th November, 1999 on the subject mentioned above and to state that the Ministry of Environment and Forests, Regional Office, Western Region, Bhopal has accorded its approval vide letter No.8C/019/99-FCW/1753, dated 27th August, 1999 for diversion of 1.170 hectares of forest land for extraction of minor minerals (Stone Quarry) in Thane District on certain conditions. Government of India has also mentioned in the said letter that State Government may issue the formal order for diversion of forest land to the user agency after the compliance of the condition No.2(b) by the project authority.

2. The project authority has deposited an amount of Rs. 19,002/- (Rs. Nineteen thousand two only) as the cost of compensatory afforestation for planting 1750 trees as per the existing wage structure in the Special Fund of the Forest Department and the case area has been demarcated as per the conditions mentioned in Government of India's above referred letter. I am, therefore, directed to convey the sanction of Government for diversion of 1.170 hectares of forest land for extraction of minor minerals (Stone Quarry) in Thane on the following conditions.

- 1) The legal status of the forest land shall remain unchanged.
- 2) The forest land shall not be utilised for any purpose other than specified in the project proposal.
- 3) The period of mining lease will be 20 years co-terminus with lease under MMRD Act.
- 4) Reclamation of the mining lease area will be done at the project cost under the supervision of Forest Department.
