कार्यपालन यंत्री, जलसंसाधन दमोह द्वारा दमोह विधानसभा क्षेत्र, विकासखण्ड दमोह में बडयाऊ गांव के निकट सतधारू नाले पर सतधारू मध्यम सिचाई परियोजना का निर्माण प्रस्तावित किया गया है। इस परियोजना में लगभग 750 हेक्टे. वनभूमि प्रभावित होगी, जिसके बदले में उतनी ही राजस्व भूमि वन विभाग को हस्तांतरित किया जाने के निवेदन पर राजस्व भूमि का राजस्व, वन एवं जल संसाधन विभाग के अधिकारी/कर्मचारियों द्वारा संयुक्त स्थल निरीक्षण किया जाकर प्रस्तावित सतधारू मध्यम सिचाई परियोजना के निर्माण हेतु वनसंरक्षण अधिनियम 1980 के तहत वनभूमि के बदले राजस्व भूमि तहसील बटियागढ़ में ग्राम शहजादपुरा में ख.नं. 3, 5, 7, 15 रकवा कमश: 21.69, 44.59, 61.31, 299.77 हेक्ट. ग्राम धूधस में ख.नं. 1, 16 रकवा कमश: 159.62, 18.20 हेक्ट., ग्राम चौपरा मडियादो में ख.नं. 123 रकवा 46.71 हेक्ट., ग्राम पिपरिया घनश्याम में ख.नं. 5, 7 रकवा कमश: 126.42, 39.62 हेक्ट., ग्राम गीदन ख.नं. 102, 180, 182 रकवा कमश: 59.88, 35.01, 29.51 हेक्ट. ग्राम सागौनी में ख.नं. 36/27क रकवा 232.44 हेक्ट. तथा तहसील हटा के ग्राम सिलापरी एवं सागौनी में ख.नं. 73, 44 रकवा कमश: 8.14, 69.27 हेक्ट. कुल तहसील बटियागढ़ के कुल ग्राम 06 तथा तहसील हटा का 01 ग्राम की कुल भूमि रकवा 1205.47 हेक्ट. भूमि केन्द्रीय सरकार के अनुमोदन उपरांत वन विभाग को हस्तांतरित करने की सहमति प्रदान की जाती है।


