Attention of the Regional Officer, Panchayat Raj Region Nizamabad District is invited to the references cited.

The Regional Officer, Panchayat Raj Region Nizamabad District is informed that vide Preference 7th cited the CCF/Conservator of Forests, Nizamabad has submitted the processed proposal for the subject project for forwarding the same to State Government. On scrutiny of the processed proposal it is found that the RoFR Certificate in the prescribed format from the concerned District Collector is not furnished. Unless RoFR Certificate or any evidence that process of obtaining RoFR certificate is furnished the processed proposal cannot be forwarded to the State Government as the same is mandatory.

In view of the above, it is requested to furnish the RoFR Certificate in the format prescribed from the concerned District Collector or furnish any evidence that the process is initiated for obtaining RoFR certificate for forwarding processed proposal to the State Government urgently.
