		saplings than selected site No. 1. The copy of revenue papers i.e. tatima and Jamabandi of said rejected/alternative site are enclosed.
3.	The State Government shall submit the certificate of non availability of administrative building or building on lease for the above said proposal to this office.	There is no Government accommodation available at Rampur Bushahr for housing the above said project. The non availability Certificate to this effect has been obtained from the Sub Divisional Officer (Civil), Rampur Bushahr, the copy of which is enclosed herewith. It is further submitted that there is also no such large Private accommodation available on rent/lease at Rampur Bushahr in which the above said Complexes can be housed.
4.	The State Government may go through the norms and correct the areas for each component to the minimum as per the norms.	The area shown in each component of the complexes is bare minimum as per the norms circulated by the Hon'ble High Court of H.P. and it is not possible to less the area of said land. The road areas are fulfilling all other requirement of modern Judicial Complexes, desirability of adopting environment friendly measures, renewal energy, rain water harvesting as well as differently-abled friendly. The Executive Engineer, HP, PWD (B&R) Division, Rampur Bushahr has also issued letter/certificate in this behalf, copy of which is enclosed herewith.

In view of the above said replies of this office, the observations

as made by the R.O., Dehradun may please be removed, accordingly.
