(i)	Short narrative of the proposals and project/scheme for which the forest land is required	:	There is one colony by name NTR nagar having 3024 households near Akkacheruvupadu locality of Nellore city. There is no direct approach road to the above colony from Nellore-Podalakur main road. Inorder to provide main road connectivity, the direct approach road is proposed with Cement Concrete . This approach road will be useful to 3024 house holds and local residents of Akkacheruvupadu.
