The Deputy Conservator of Forests, Alibag has submitted the consolidated proposal mentioned in the subject vide his letter No. A/20/Land/320, dated 28.05.2019, letter No. A/20/Land/1308, dated 04.11.2019 & letter No.1526, dt.01.01.2020. Xerox copy of the same are enclosed herewith for your ready reference. The Project Agency of this project is Deputy Chief Project Manager-1, Mumbai Railway Vikas Corporation, 2<sup>nd</sup> floor, Churchgate Station Building, Churchgate, Mumbai - 400 020.

The Mumbai suburban railway network on the Central Railway has two corridors - i) Main line and ii) Harbour line. The Main line corridor connect Chhatrapati Shivaji Terminus (CSTM) with Kalyan. The Harbour line corridor starts at CSTM and terminates at Panvel. The Navi Mumbai area, especially around Panvel, has witnessed significant urbanization and population growth, the area between Panvel and Karjat is also developing rapidly and hence there is increasing demand for extending the suburban train service to Karjat. Currently, a single line 29.60 km. track connects Panvel with Karjat. It caters only to goods and a few long distance passenger trains. SheetalRaut/504)Panvel-Karjat-9.1321 ha.

Mumbai Rail Vikas Corporation (MRVC) plans to increase network capacity and improve customer services on this corridor. In view of this, about 9.13.21 ha. of Forest land is required to be diverted for Doubling Railway Line of this railway having length of 29.60 km. Which passes through 8 villages Belavali, Bhingar, Barvai, Bherale, Tal. Panvel. And Lodhivali, Vavarle, Tal. Khalapur and Kirvali, Vanjale, Tal. Karjat, Raigad District.

Forest land for Panvel - Karjat Suburban Corridor Project (Double Railway Line) from Raigad District in the State of Maharashtra.
