Mukund Reddy, Dy.C.F., District Forest Officer, Suryapet of the Diversion of 0.0989 Ha of Forest Land for laying of Road from NCL Factory Main gate Wall up to Outside of the Factory in Compt. No. 14 of Sulthanpur RF of Huzurnagar Range of Suryapet Division and District on 06.12.2019.

- I have inspected the forest land proposed for diversion of 0.0989 ha of Forest Land for laying of Road from NCL Factory Main gate wall up to Outside of the Factory.
- The proposed diverted Area of 0.0989 Ha of Forest Land is in Compt. No. 14 of Sulthanpur RF of Huzurnagar Range. The road starts at 16.71645287 N, 79.82126799 E and ends at 16.71633981 N, 79.82177951 E in Compt. No.14 of Sulthanpur RF in Huzurnagar Range.
- The details of forest areas proposed for diversion are as follows:
 - The forests area is Scrub Forests with <0.1 canopy density.
 - The said proposed area for diversion does not form part of National Park, Wildlife Sanctuary, Biosphere reserve, Tiger reserve, Elephant Corridor etc.
 - No rare / endangered / unique species of flora and fauna are found in the forest area proposed for diversion.
 - There are no protected Archaeological / Heritage site / defense establishment or any other important monument in the forest area proposed for diversion.

RoRF Claims:

 There are no claims under RoFR in the Diverted Forest area and the District Collector Vide reference Lr. No. E1/433/2018, has already issued Form-I certificate under RoFR Act in the prescribed manner with Gram Sabha Resolution for diversion of Forest Land stating that there is no objection.

Enumeration of tree growth:

- There are no trees in the proposed diverted forest area.
- <u>Fauna:</u> The fauna found near the proposed area are Spotted deer, Monitor Lizard, Wild Boar, Peacocks, Rabbits, etc.
- No Work in violation of Forest (Conservation) Act, 1980 has been committed by the User Agency.

Recommendation:

The project of laying of Road from NCL Factory Main Gate wall to Outside of the Factory is intended for providing the road facility to the NCL Factory. For an extent of 0.0989 Ha through Sulthanpur RF, Compt. No. 14 Forest land is diverted. The project is recommended subject to the following conditions:

- i. Provide funds to raise avenue plantation of 5Km and to establish permanent nursery site at Huzurnagar Range to strengthen planting activities.
- ii. User Agency has to provide funds for Wild Life Mitigation plan which includes provisions for taking up works like Saucer pit formation with refilling of water.
- iii. The user agency should not put any waste or other debris generated from the factory or mining in reserved forest area.
- iv. User Agency has to erect a 4 ft height parapet wall on either side of the area proposed for diversion.
