However, Villages -Niwale, Tanali, Chandel, Dakale, Tamave Paiki Kulyachiwadi, Sonarli paiki dhangarwada Tal-Shahuwadi Dist-Kolhapur, And Village - Gothane, Sangmeshwar Tahsil dist- Ratnagiri this villages included in chandoli national park due to 792 pepole affected in this project for this reason forest area 318.04 ha divered for agriculture use in Walur, Karanjoshi, Kotoli, Perid, Bhairewadi, Jeur, Porle Traf Thane, Male, Vadgao, Tasgao, Danoli, Madale, Pargaon, Ambapwadi and Tamdalge. Hence, proposal has been submitted under the Forest (Conservation) Act, 1980 for disforestation.
