The above proposal has been scrutinized in this office, and Part-III, Form-A has





This road is a State Highways road which passes through Pallikonda RF to a stretch of 1.050 Km. The Airtel (Telesonic Network Limited) has proposed to lay the underground OFC cable to a length of 1.05 km. to a width of 0.60 mts. and to a depth of 1.00 mts. The proposed alignment of the OFC cable to be laid in the forest area is along the State Highways Road which passes through Pallikonda Reserve Forest. In the alignment proposed to lay the OFC cable, there is no involvement of any felling of trees. Further, there is no rare, endangered and unique species of flora and fauna in the forest area proposed for diversion. Hence the proposal may be recommended.</p>
