No. 1 have been executed in between the LSGD, RUIFDCO, concerned ULB and RIDCOR for facilitation of construction of ROB's in accordance to the guidelines in Umbrella MOU executed between GoR and RIDCOR.

1. MOU signed by the Administrative Department and Agreement signed by the Concerned Municipal Council/Board/Municipality issued for project execution
2. Municipal Council / Board / Municipality Kishangarh, Hindaun, Makarana, Neem ka Thana, Reengus, Chittorgarh, Suratgarh and Sangria shall be solely

responsible for their responsibilities as per MOU and Agreement for execution of construction of ROB's. 288

3. Municipal Council/Board /Municipality will be responsible for all land acquisition and make encumbrance free land available for construction of the bridge as well as for diversion road as per the project plan to be indicated by IRCON/RIDCOR.
4. The land acquisition cost has been sanctioned from State Plan and Budget for above ROB's. This may be utilized for any requirement of land acquisition through Director, Director Local Bodies Jaipur.
5. Assisting IRCON/RIDCOR in shifting of utilities, permission from different departments is the key responsibility of the concerned ULB's and accordingly proactive action should be taken.
