The ACS UDH&LSGD showed his displeasure and concern about the non fulfillment of the commitments made by IRCON in earlier meetings and lack of sincere efforts in targeted completion by IRCON. It was observed that IRCON has not come up to the expectations as per the original thought and commitment for timely completion of the works, even in the cases where complete site has been made available in very initial stage. Proper pursuance is not made by IRCON to get the required approvals even from Railway resulting into delay in completion of the projects.
