2. Briefly averred, prosecution version is that on 18.11.2014 at about 3:00 P.M., during patrolling/ search made by Rajinder Kour, Forest Guard Incharge Bhimpur Beat District Pathankot it was found that the accused had encroached Government Protected forest Pathankot- A.P.K. road HM 13-14 left side 6m x 33m = 198 sq.mtr of the forest department, without prior permission from the Govt of India (Ministry of Environment and Forest) belonging to Forest Department and thereby accused has committed offence under Section 32(G)-33 (c) read with section 63 of Indian Forest Act 1927. During further investigation, relevant documents were taken into possession. After completion of necessary formalities, complaint against the accused presented in the Court.

3. On appearance of accused in the Court, copies of documents relied upon by the prosecution were supplied to the accused free of cost as required under section 207 Cr.P.C.

4. Finding a prima-facie case under section 32(G)-33 (c) read with Section 63 of Indian Forest Act made out against accused, he
