1	As per DSS Analysis of the KML file uploaded on PARIVESH portal, it has been observed that the boundaries of Mine Lease Area, 68.704 ha and 19.50 ha already diverted forest areas have been changed again. The State govt. is therefore requested to scrutinize the KML files based on ground truthing and upload the complete KML file of the mining lease including the detail of forest and non-forest lands involved.	The KML file of boundaries of Mine Lease Area of 68.704 ha and 19.50 ha already diverted forest area submitted in the last reply vide letter. सन्दर्भ सं.: वेकोलि/कन्हान/क्षे.म.प्र./2022-23/1378 on dated 26/07/2022 has been prepared based on ground truthing done by State Forest Deptt. officials (Chhindwara Forest Division). The complete KML file of Mining Lease including the detail of Forest and Non-forest land is hereby submitted for ready reference in a CD (Annexure-I). The same is also uploaded on the Parivesh Portal.
2.	Initially 68.704 ha forest area was diverted for underground mining and thereafter out of said 68.704 ha, an area of 19.50 ha was diverted for opencast mining. However, considering the economical viability of the said project and other geographical factors like faults etc. decision

	<p>proposal for 14.0 ha open cast mining has been submitted. This implies that the State Govt. / User Agency is submitting the proposals in piecemeal. The justification for the same may be submitted. The State Govt. shall also indicate the prospective plan for diversion of forest land / land use change of the remaining area in the Mining Lease.</p>	<p>to under take Opencast Mining was taken. The same has been communicated to Forest Deptt./ MoEF&CC after which clearance for the Scheme / PR for opencast mining within 19.50 ha forest land was accorded by MoEF&CC in the year 2015.</p> <p>At present the operations in 19.50 Ha are to be expanded so that energy need of the State as well as Nation can be catered. As such Scheme for Expansion of Opencast mining in Phase-II involving 14.00 ha forest land has been prepared and accordingly the application for diversion of 14.0 ha forest land is applied by the User Agency.</p> <p>It is also to mention that the remaining area of within Mining Lease may be converted in opencast mining in future but it depends on economical viability.</p>
