It is to inform that, the above proposals were approved by the Govt. of A.P., vide G.O. Rt.No.170; Dt:30/10/2017 of Environment & Forest Dept. and a “Demand Notice” is also received by this office for payment of Net Present Value (NPV). While uploading the Demand Notice through online in the Ministry’s portal, it came to know that, the details of “DGPS survey for CA Land sought by the DFO, Ananthapuramu as per reference 2nd & 3rd cited above, is pending at user Agency Level.

In this office reference 4th cited, it was already informed that, the CA land is not required in this case as the proposal falls in L.W. District and number of trees to be felled are also less than the specified number (i.e., 50 no.s/ Hactare).

Accordingly, after joint inspection by both the departments, DFO, Ananthapuramu furnished the detailed report to the PCCF., A.P., GUNTUR vide reference 7th cited and the same is recommended to the Government by the PCCF, and the Government finally accorded “In principle stage-I approval”.

Hence, I request the Divisional Forest Officer, Ananthapuramu to take immediate necessary action for operating the request of user agency through online in the Ministry’s portal at an earliest to pay the NPV.

Sub:- (R&B) NH Division, Anantapuramu – NH-63 (New NH-67) proposals for diversion 3.582 Ha of Forest Land for 4/6 Lanning of Karnataka/Andhra Pradesh state border to Gooty section of NH-63 from design Ch.375+740 to Ch.433+030 in the state of Andhra Pradesh” – Detailed report on number of falling trees - Submitted – Reg.

It is to inform that, during our joint inspection, we have noticed only 18.no of trees with the girth of more than 30 cm which are to be felled for “Four Lanning of Road” in the proposed diversion of 3.582.Ha. of forest land as against 752 numbers of trees stated in the report submitted to Government of India vide PCCF reference Rc.No.1697/2016/FCA-3, dated 23.11.2016.

Accordingly, considering the number of trees to be felled with more than 30.cms girth and all other affected are only plants which are having girth less than 30cm and also considering the area of forest land to be diverted, the state government is empowered to accord permission in L.W.District for not more than 5 Ha. of diversion of forest land subject to the condition of the forest area is falling outside the protected area and felling of trees is below 50 numbers per hectare.

In this connection, I request the Divisional Forest Officer, Ananthapuramu that CA land is not required in this case as the total number of trees in the proposed diversion of forest land of 3.582 Ha. is 18 numbers only. Hence, I request the Divisional Forest Officer, Ananthapuramu to kindly review the decision of CA land for our case and kindly obtain necessary orders from the Government for diversion of forest land at an early date, as the project is already delayed due to non handing over of diversion of forest land.
