Sub: Diversion of 12.05 Hectares of Forest Land in Unclassified State Forest under Nampong Forest Division of Changlang District for laying of new gas & oil pipeline from Kumchai EPS (Arunachal Pradesh) to Kusijan FGGS(Assam).

Dear Sir,

For the purpose of exploration, development and production of hydrocarbon in Kumchai Oil field under Ningru Petroleum Mining Lease (PML) of Oil India Limited and transportation of produced hydrocarbon from the field, Oil India Limited (OIL) proposed to lay Cross-country 8 inch Crude Oil & 14 inch Gas pipeline from Kumchai EPS (Arunachal Pradesh) to Kusijan FGGS (Assam). For the purpose, OIL has surveyed the proposed pipeline route and the forestland area required in Assam part is 27.43 ha (Length-18.28km, width-15m) which are falling in Duarmara Reserve Forest (4.42 Ha), Burhidihing Reserve Forest (2.06 Ha) under Doomdooma Forest Division and Upper Dihing Reserve Forest East Block (16.73 Ha) and Upper Dihing Reserve Forest West Block (4.22 Ha) under Digboi Forest Division in Tinsukia district of Assam

2.0 View above, we are submitting herewith a proposal for diversion of 27.43 ha of forestland falling in Duarmara Reserve Forest (4.42 Ha), Burhidihing Reserve Forest (2.06 Ha) under Doomdooma Forest Division and Upper Dihing Reserve Forest East Block (16.73 Ha) and Upper Dihing Reserve Forest West Block (4.22 Ha) under Digboi Forest Division in Tinsukia district of Assam for your kind consideration and necessary approval, please.
