In compliance of this observation a High Level meeting held on dated 29 th September, 2022 under chairmanship of Chief Secretary Govt. of Rajasthan and in presence of Principal Secretary (Forest), Principal Secretary (Finance), Secretary (Civil Aviation Department Govt of Rajasthan), District Collector, Kota, UIT Secretary, Kota and Airport Director, Kota wherein it is decided that the Cost for Construction of boundary wall for these two patches will be borne by the State Government. In this regards separate undertaking is also enclosed.
