of the Central Government in accordance with Section 2 of the
Forest (Conservation) Act, 1980.

2. The proposal has been examined by the Advisory
Committee constituted by the Central Government under Section 3
of the aforesaid Act.

3. After careful consideration of the proposal of the
State Government and on the basis of the recommendations of
the abovementioned Advisory Committee, the Central Government
hereby conveys its approval under Section 2 of the Forest
(Conservation) Act, 1980, for diversion of 5.62 ha. of forest
land for oil drilling in Tirap District subject to the following
conditions:-

(i) Legal status will remain unchanged.


(ii) Compensatory afforestation will be raised
over 11.24 ha. of degraded forests. The
cost of plantations which are estimated at
Rs.1,47,733 will be paid by M/S Oil India Ltd.

intimated . . . The Chief Conservator of Forests, Itanagar has instructed that the Central Government have accorded approval under section 2 of the Forest (Conservation) act 1980 for diversion of 5.62 Hect of Forest land for Oil & Drilling at location "KUC" (3.96 Hect) & "KHY" (1.66 Hect) subject to following condition.

- i. Legal status of Forest land will remain un-changed.
- ii. Compensatory afforestation will be raised over 11.24 Hect. of degraded Forest . The cost of plantations which are estimated at Rs. 1,47,738/- will be paid by M/S Oil India Limited.

M/S Oil India Limited have deposited the estimated cost for compensatory plantations and therefore they may be allowed to carry out their works in the above mentioned locations i.e. "KUC" = 3.96 Hect -Kumchai U.S.F. areas of Diyun Range & "KHY" = 1.66 Hect of Kharsang U.S.F. area of Namphai Range.

The compensatory plantation are to be raised over 11.24 Hect of degraded Forest as under -

7.92 Hect. in Diyun Range & 3.32 Hect at Namphai Range . You are also asked to initiate necessary action for the same.

You should also ensure that the forest vegetation standing if any or felled by the project authority in the above mentioned forest area approved for diversion is taken by the Department and details intimated to this office for disposal of the same.

You will also monitor the condition stipulated by Central Government mentioned above.
