ORDER

Whereas, vide CCF Jammu No: CCFJ/Plg/22-23/43/285-88 dt 12.05.2022, approval / sanction has been accorded for work programme of Compensatory Afforestation w.r.t Forest Clearance for "Construction of road from Devak Bambliya connecting Sanki-Deoli & hathal-Sarooti" to the tune of Rs 21,49,311/- to treat an area of 14 hectares; and

Whereas, the DFO Nowshera, vide No: DFO/NSR/1434-35 dt 30.09.2022, has reported that an EDS has been raised by the IRO Jammu dated 30.06.2022 regarding the change in alignment in the forest area and accordingly the DFO Nowshera submitted revised work programme to treat an area of 12 hectares with financial implications of Rs 25,04,144/-, which has been recommended by the CF West Circle vide above quoted reference.

Now, therefore, in view of recommendations of CF West Circle, the revised work proposal for Compensatory Afforestation to be done in lieu of diversion of 6.051 hectares of forest land in Nowshera Forest Division for "Construction of road from Devak Bambliya connecting Sanki-Deoli & hathal-Sarooti" by PWD to the tune of Rs. 25,04,144/-, is hereby approved / sanctioned, as per the detail given below:-
