The petitioner Chhattisgarh State Power Transmission Co. Ltd. (CSPTCL or petitioner hereinafter) is a body incorporated under the provisions of the Companies Act, 1956 and having its registered office at Vidyut Sewa Bhawan, Dangania, Raipur. CSPTCL is one of the successor companies of erstwhile Chhartisgarh State Electricity Board (CSEB) and also State transmission utility of Chhattisgarh State. CSPTCL has filed this petition for approval of revision of capital investment plan for the control period from FY 2016-17 to FY 2020-21 under Section 62 and 86 of the Electricity Act, 2003 read with the Chhattisgarh State Electricity Regulatory Commission (Terms and Conditions for determination of tariff according to Multi-Year Tariff principles and Methodology and Procedure for determination of Expected revenue from Tariff and Charges) Regulations, 2015 (hereinafter referred as "MYT Regulation, 2013") and relevant orders and direction of the Commission.

As per provision of the above regulations, CSPTCL had filed a petition bearing no 101 of 2015 (M)) before the Commission for approval of Capital Investment Plan (CIP) for the control period FY 2016-17 to 2020-21. Commission vide order dated 26.03.2016 had approved the CIP in respect of the aforesaid petition.

As per provision of the Regulation 7.5 and 7.6 of MYT Regulations, 2015, CSPTCL 2. may file petition for deviation/change in approved Capital Investment Plan or for approval of additional works in capital investment plan. Clause 7.5 and 7.6 of MYT Regulations, 2015, are reproduced below:

12.9 Construction of 220 kV Substation Dharamjaigarh & Its associated transmission Lines

CSPTCL has proposed construction of 220 kV Substation Dharamjaigath & Its associated transmission Lines. Commission vide order dated 26,03,2016 in CIP FY 17 to FY 21 has approved construction of 132/33 kV substation Dharamjaigath along with associated 132 kV lines. Now CSPTCL submitted that to improve the reliability/stability/voltage profile and to meet future load growth of Raigath. Ambikapur and Jashpur district it would be proper to construction of 220/132 kV substation Dharamjaigarh in place of approved 132KV substation at Dharamjaigarh. It is also proposed to construct LILO of 220 kV DSPM (Korba)-Banari line of route length 65 Km up to proposed 220/132 kV substation Dharamjaigarh and LILO of 132 kV Batauli-Patthalgaon line of route length 40 Km at 220/132 kV substation Dharamjaigarh.
