

- 13) Deputy Conservator of Forests remarks as to whether he agrees with the above details:

REMARKS:- I agrees with the above details. It appears that, the area under proposal is earlier used by locals to communicate to their households, which are located on both sides of the area under the proposal. There is no other alternative approach to reach the non forest land except the constructed road. Violation is done by private person. The offence has been booked against violators including P.A. The legal action under the provisions of IFA 1927 is in process. The proposal is recommended subject to deposition of five (5) times Net Present Value (NPV) of the violated area by the project authority as directions issued in the Part-B, Chapter I, Rule 1.21 of the Forest (Conservation) Rule, 2003 published by GOI vide letter no. F.No. 5-2/2017-FC, dated 28/03/2019.
