13) Specific recommendation of DCF for acceptance or otherwise of proposal with reasons.

The proposal is recommended for acceptance; as the proposed Forest lands 0.64 ha. from gut no 191 Comp. no 151, at Solashi, Tal. - Koregaon, & G. no 1010/1, Comp. no. 36 at Village Vele, Tal. – Wai, Dist. Satara, for laying of overground 440-volt L.T. Aerial Bunched Cable twisted electric line (Insulated Cable) for Harihareshwer Temple at Solashi, & Dhareshwer Temple at Vele, Tal. Wai, Dist.- Satara, under DPDC Scheme. In this project the Aerial Bunched Cable twisted cable (Insulated cable) will be used in forest area. Which also reduce accident of forest fire due to electric line, & to prevent death of wild animal & birds.

There is no alternative non-forest land available, and the forest area is to be diverted is not sensitive and will not have any adverse effect on the ecology of area. Hence this proposal is recommended.
