Administrative Approval is hereby accorded for Const. of road from Kaldi to Khurrian alongwith drainage (phase-1st) (Under State Plan 2021-22) at an estimated cost of Rs. 255.23 lacs (Rupees Two Crore Fifty Five lacs & Twenty Three Thousands) only as per detail and cost abstract to this Order as per Annexure-I

The Administrative approval is however, subject to the following conditions:-

1. The works shall be executed after observing all Codal formalities/ procedures.
2. It must be ensured that there shall be no multi-source of funding or overlapping of scheme under different programme.
3. The scheme shall be executed only after encumbrance's free land is available.
4. That the works are executed strictly as per provisions and specifications of the sanctioned estimates.
5. Schemes/ project shall be completed within stipulated time.
6. There is no time over-run or cost over-run involved in the project.
7. Accord of Administrative Approval shall not be treated as an authority to spend money not provided for in the budget. However the work shall be excuted only to the extent funds released during the current financial year
8. Quality control is maintained in accordance with relevant standards set under MORTH/IRC/BIS/NBC. Code of practice.
9. The detailed estimate of the work shall be technically sanctioned by the competent authority and proposals strictly devised and designed as per the relevant code of MORD/MORTH/IRC/BIS/NBC specifications.
10. Any such item (s) not covered under relevant schedule of rates is paid in accordance with the set codal procedure.
11. Rates provided as lowest market rates (LMR) shall not be construed as approved rates. Executive Engineer shall follow the codal procedure while making such payments.
12. The NOC from the concerned regulatory Authorities is obtained before the commencement of the work.
