APPLICATION FOR PRIOR APPROVAL FOR DIVERSION OF 193.845 HA. OF FOREST LAND (149.620 HA RESERVE FOREST + 0.129 HA REVENUE FOREST + 44.096 HA DLC FOREST), FOR BALRAM OCP, HINGULA AREA OF M/s MAHANADI COALFIELDS LIMITED, TALCHER RANGE, ANGUL DIVISION, ANGUL DISTRICT, ODISHA.

1. PROJECT DETAILS :-

i. Short narrative of the Proposal and Project /Scheme for which the forest land is required.

The Mahanadi Coalfields Limited (MCL) is a subsidiary company of Coal India limited a Government Company owned by Government of India. It is engaged in coal mining in the state of Odisha. The activities of MCL are spread over in Angul, Jharsuguda and Sundergarh districts. Mahanadi Coalfields Limited (MCL) Total Coal Mining Projects sanctioned till date in MCL are 53 (including 3 exhausted Projects). The rated Production Capacity of these sanctioned Projects was 285.61Mty, with a sanctioned Capital outlay of Rs.31734.03 Crs (including RCE). Out of total 53 Projects, 39 Projects are completed Projects and 14 Projects are On-going Projects. These 14 on-going projects have rated capacity of 201.83 Mty with capital investment of Rs.27463.11 Crs.

The Balram OCP Expn Project is Opencast project and located in Talcher Tahasil of Angul District of Odisha State. The total requirement of land for the Project is 1265 Ha, of which 149.62 Ha is Reserve Forest land, 0.129 Ha is Revenue Forest Land and 44.096 Ha DLC forest. The balance is non forest land. Hence, the present application is for diversion of 193.845 Ha. of forest land.

Total extractable coal reserves of this project are about 712.21 million tonnes including 111.261 Million Tonnes in 193.845 Ha. of forest land. The

annual production is around 15 Million tonnes. There are total no. 19 seams including splits with the thickness of coal seams is ranging from 0.3m to 22 m and located at a depth of about 10.00m to 270m. The life of the Project is about 49 years excluding pre-mining & post-mining periods.

For the propose of creation of compensatory afforestation (double the degraded forest lands) in respect of proposals seeking prior approval of Central Government under Sec.2 of Forest (Conservation) Act, 1980. Hence , degraded forest area of 387.332 Ha, is required towards CA purpose for approving the diversion of 193.845 Ha, forest land situated in the Project Area.

Balram OCP Expn Project requested DFO, Dhenkanal for identifying the degraded forest lands for CA Purpose in Dhenkanal Division and 387.332 Ha, in Mahbirod Range of Dhenkanal Division was identified, Pillar posting done and DGPS Survey conducted from 24.01.2021 to completed 04.03.2021 and work completion certificate was issued vide memo no. 1046 dated 17.03.2021 by Range officer, Mahabirod Range, Dhenkanal.

Regarding Safety Zone it is to state that the area along the forest area proposed for diversion is coming out to be 1.851 Ha. Balram OCP, Hingula Area, MCL agrees to pay the cost for protection and regeneration of safety zone area and also for cost of raising plantation in 1.5 times safety zone area in 2.776 Ha. in degraded forest area.

- <u>iv.</u> Justification for locating the project in forest area :-

As area proposed for diversion is coal – bearing and as such it is a site specific activity and the justification is enclosed with the application.

The project likely to generate direct employment of about 1157 persons in addition to indirect employment in the project during the mining operations.
