7.	The village level committee and sub divisional level committee proceedings are undated. The State Govt may mentioned the procedurally correct date and upload the same in online Part I. The State Govt has provided/upload the scanned copy of GIS software generated geo referenced digital map without showing geo coordinates to the exact scale of the proposed road of all turns and at 200-300m distance. The State Govt may provide/upload the correct map showing geo coordinates at 200 to 300m interval along the alignment including all turning points and ensure the uploading of correct revised map in online Part I.	Map showing geo coordinates at 200 to 300 m interval along the alignment including all turning points on exact to the scale is uploaded in Part-I C(iv)
9.	The geo referenced digital map of area proposed for CA uploaded is not acceptable for the purpose. The State Govt may provide/upload GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/closed area) file.	GIS software generated geo referenced digital map of the area proposed for CA providing geo coordinates at all corner points in shape (polygon/closed area) file uploaded.
10.	As per Decision Support System (DSS) analysis, out the total area of 8.37 ha proposed for CA, 5 ha is on moderately dense forest. State Govt may replace this 5 ha area with some other area suitable for CA and provide/upload revised digital map, SoI toposheet map and KML file of the complete 8.37 ha CA area again after making the above change.	As per Decision Support System (DSS) analysis, out the total area of 8.37 ha proposed for CA, 5 ha is not dense forest. It is only dense bushes at proposed area. Hence there is no need to replace the proposed area. If necessary the certificate for the same may be provided from competent authority.
11.	The area of CA is mentioned 4.50 ha in online Part I instead of 8.37 or 8.50 ha as per the CA scheme uploaded in online Part II.	The area of CA is corrected in Serial L (iv) b and filled 8.37 ha. CA scheme for same area be uploaded as a additional information in serial no. 11... Form A Part I.
