

2	Project details.	: History of Chromite mining in Sukinda Valley started way back in 1949 when the Steel Company's Prospecting Division discovered the occurrence of chromite. The Sukinda Chromite Mine of Tata Iron & Steel Company Limited (erstwhile name of Tata Steel Limited) was originally granted under Prospecting License & Mining Lease by the then Raja of Sukindagarh Estate over an area of 7 sq. miles (1813 ha) for a period of 20 years in the year 1952. After the abolition of Estate, the State Government ratified the mining lease for a period of 20 years with effect from 12.01.1953. Subsequently, 1 st renewal of the mining lease was granted for a period of 20 years with effect from 12.01.1973 over a reduced area of 1261.476 ha. The 2 nd renewal Lease Deed over a further reduced area of 406 ha was executed on 18.05.1998 for a period of 20 years with effect from 12.01.1993. Subsequent to the recommendations of the Sharma Committee Report dated 16.8.1995, Central Government Order dated 17.08.1995 and Hon'ble Supreme Court's judgment dated 23.07.1996, the State Government communicated the decision of the Central Government; reducing the Company's chromite mining lease-hold to 406 ha and demarcating the reduced lease area of 406 ha vide the State Government's memo no. III (G) SM-34/96-7746 dated 07.08.1996. - Annexure - II,III,IV & V The leasehold area of 406 ha comprises 73.697 ha of forest land and 332.303 ha of Non-Forest land. The entire forest land within the lease is 73.697 ha which had been broken prior to 25.10.1980 and the diversion of the same had already been approved by the Ministry of Environment and Forests for the 2 nd lease renewal period. The validity period for the 2nd renewal of the Mining Lease is from

		<p>12.01.1993 to 11.01.2013.</p> <p>The lease is due for its 3rd renewal for a further period of 20 years from 12.01.2013 to 11.01.2033. The Company has applied for 3rd Renewal of the Mining Lease in due time (one year before the schedule date of expiry in accordance with Rule 24A (1) of the Mineral Concession Rules, 1960) for a further period of 20 years. Dy. Director of Mines has received the same in Form-D by DDM, JK Road with RML Sl no. 364 vide his letter vide Memo No. 48, dated 04.01.2012.</p> <p>Tata Steel Limited submits that on 17.05.2014, on a joint reading of the Orders of the Hon'ble Supreme Court dated 02.05.2014 in I.A. The lease area comprises of a part of Forest Block No. 27 under Mahagiri DPF, Khesera/ village Forest and Non-Forest land. During the subsisting period of this lease, forest clearance is required.</p> <p>Hal Settlement was published in the year 1992-93 in which forest land is 73.697 ha and Non-forest land-332.303 ha of the 406 ha of the lease-hold. The entire area of 406 ha is broken up much prior to 25.10.1980.</p> <p>The Company has deposited NPV of Rs 5, 37, 98,810.00/- over 73.697 ha of forest land on 10.01.2013. Further, as NPV demanded by the Divisional Forest Officer, Cuttack on 20.05.2015 over 330.972 ha of Forest Land as on 25.10.1980, Company has already deposited Rs. 24, 16, 09,560/- on 20.07.2015. 		<p>Ore. The Chrome Ore produced from this mine is supplied to the Company's Beneficiation Plant, Ferro Alloy Plants at Bamnipal and Athagarh and other industries. The chrome concentrate and Ferro Alloys produced by the company is then sold within the country as well as exported. The Pyroxenite ore produced from this mine is used as a flux at the Company's Steel Plant at Jamshedpur.</p> <p>Approval for diversion of 73.697 ha of the entire forestland within the Mining Lease of Sukinda Chromite Mine over the lease-hold area of 406 ha., was accorded vide letter No. 8-78/96-FC dated 27.01.1998 of Asstt. Ministry of Environment & Forests (MoEF) for undertaking this change of technology from open cast to underground mining, increased production [Chrome ore (ROM) to 2.40 MTPA, Pyroxenite (ROM) to 0.50 MTPA & Chrome concentrate production to 0.65 MTPA], increase in project area and renewal of the lease. Consequent to successful completion of Public Hearing on 14.12.2012, our case was heard by EAC, Mining on 14.03.2013 and 18.04.2013 and recommended the case to the MoEF, GoI for grant of Environmental Clearance. MoEF&CC. Govt. of India granted the Environmental Clearance vide letter No J-11015/96/2011-IA.II(M) dated 6.09.2013.

The mine has been granted Consent to Operate under Air and Water Acts by the State Pollution Control Board, Odisha vide Consent Order no. 7552/ IND-I-CON-226, Dt 03.05.2011, valid till 31.03.2016.

Being a Mining Project, the same is site specific. The chrome ore occurs within the Company's lease-hold in the form of three parallel almost vertical narrow bands stretching from east to west. While two of these chrome ore bands are friable and ferruginous in nature, the southern ore band which falls within the forestland is lumpy and siliceous in nature. Each of these three ore bands have distinct chemical characteristics, and therefore the ore from all the three ore bands is required to be mined for meeting the requirements of the Company's downstream plants.

The Company has undertaken further geological exploration to systematically prove the existence of ore at greater depths up to 250m-300 m as per the exploration proposal in the already Approved Mining Plan/ Scheme of Mining. Having established the occurrence of chrome ore at greater depths, the Company has also made further investigations regarding the geo-technical properties of the ore and wall rocks with the assistance of CIMFR, Dhanbad. The Company has also undertaken geo-hydrological studies. The current opencast mining operations have already reached a depth of 85-90 m. Considering the restrictions of the lease boundaries and the maximum safe and stable slope angles, the possibility of continuing opencast mining operations is therefore limited. The Company therefore proposes to switch over to underground mining before the current opencast mining operations reaches its ultimate pit depths in order to sustain its mining operations for meeting its chrome ore requirements.

The Company has already completed its Feasibility Study on underground mining by engaging mining experts from CIMFR, Nagpur and SRK, South Africa.

		<p>The current production level from this mine is around 0.4 million tonnes/ annum of chrome concentrate, 0.50 million tonnes/ annum of chrome ore and 0.225 million tonnes/ annum of pyroxenite. Keeping in view the future growth plans of the Company, the opencast and underground mine is proposed to be designed for a ROM production capacity of 2.4 million tonnes/ annum of chrome ore, 0.50 million tonnes/ annum of pyroxenite (ROM) and 0.65 million tonnes/ annum of chrome concentrate. Since it shall take considerable time for development of the underground mine for it to reach the above mentioned steady state production level, the production during the intervening period shall be met from both opencast and underground operations during the mining lease period.</p> <p>The Site Specific Wildlife Conservation Plan submitted by the Company and the same has been approved by PCCF (WL&CWLW) vide memo no. 4895/1 WL-SSP-92/2015, dated 10.06.2015.</p>
