Gurudongmar Lake is one of the highest lakes in the world and is located at an altitude of 17800 feet above the sea level. It is one of the most important tourist destinations of Sikkim due to its pristine beauty and landscape. The entire areas towards Gurudongmar are part of a plateau which is known for its clod deserts and rich fauna. Many exotic animals like the musk deer, Tibetan sheep, goat etc. are found in the plateau which makes the area a heavenly destination.

Over the year, the tourist inflow into Gurudongmar has increased exponentially due to the sheer natural beauty of the area. This tourist inflow is further stated to grow given the improving road condition in the area. Gurudongmar has thus become an important source of livelihood to the people of Lachen. The Lachen town has developed to cater to tourist visiting Gurudongmar and Thangu. Thus today most people of the town are now engaged in Tourism and this will help in future conservation of forest and environments. Today people are less dependent on the forests for their livelihood and in fact the traditional Dzumsa is one of the important institutions furthering the cause of the conservation of the forest and natural habitat of the animals.

Currently despite the high growth of the number of tourists visiting the area and lake, the infrastructure to cater to tourists is inadequate. There are hardly any facilities for tourist reaching the area. Since Gurudongmar is located at a high elevation, the oxygen level in the area is very low. Due to this many tourists develop mountain sickness thereby causing disruption in their travel schedules. In order to undertake the scientific and proper growth of tourism in the area, it is important to develop an integrated green tourist complex and also conserve the fragile ecology.

Integrated Green tourist Complex at Gurudongmar.

In order to cater to the needs of the tourists visiting Gurudongmar Lake, an integrated Green Tourist Complex shall be developed at Yumtso near Gurudongmar which shall consist of the following components:
