SITE INSPECTION REPORT

M/s Himachal Slates and Stones, through its proprietor, Sh. Neeraj Nayar, has applied for renewal of mining permission granted to them under the provisions of Forest Conservation Act, 1980 for a further period of 5 years.

Diversion of 1.3920 ha of forest land in Makroti DPF of Chamba Forest Division was originally approved in their favour vide C.F. (Central) letter No. 9-1209-ROC/1773 dated 6.11.2001. The approval was further renewed for five years w.e.f. 5.11.2011 vide latter No. FFE-B-F (2)-3/2013(FCA) dated 06.07.2013 upto 04.11.2016. As this renewal is also coming to an end, the user agency has applied for further renewal for 5 years. The Govt. of Himachal Pradesh has already granted approval for extension of mining lease for 15 years i.e. w.e.f. 01.09.2005 to 31.8.2020.

The site was inspected by undersigned on 20th September, 2016. The project envisages the user of forest land for mining of slate. On inspection of site it was found that the legal status of 1.3920 Ha. of forest land involved in the project is DPF being part of DPF Makroti. The area was previously diverted for three components i.e. 0.8 Ha. for extraction of slates, 0.1920 Ha. for stocking of material and 0.4 Ha. for dumping of debris. The user agency is using the diverted land accordingly. The user agency is doing open cast mining in the diverted land. The area is rocky and no flora or fauna is existing in the diverted area. No damage to the adjoining forest area was noticed during the site inspection.
