
Kind attention is invited to the reference 2nd cited , where in , this office have submitted the **Form-A (Part-I): Diversion of Forest Land proposals to the District Forest Officer ,YSR(T) Division, Kadapa .** The District Forest Officer ,YSR(T) Division, Kadapa vide reference 3rd cited has returned the forest proposal duly informing that a writ petition No. 6412/2024 was filed in the Hon'ble High Court , A.P regarding cancelling the D.Form pattas in respect of the lands in Sy.No. 2233/ 4 , 2244/2 2219/3 , 2229/4, 2228/2, 2228/1 , 2229/2 , 2228/4 , 2233/5 , 2230/2 , 2230/3 , 2230/4 , 2233/3 , 2232/3 , 2232/1 2243/1 , 2219/1 , 2219/4 , 2231/4 , 2244/3, 2231/1, 2244/1, 2219/2 , 2231/2 , 2230/1 , 2230/3 , 2233/2 , 2242/1 , 2234/3 , 2230/1 , 2219/2, 2232/4 , 2232/2 , 2243/2 , 2233/1, 2231/3 each measuring an extent of 1.50 acres situated at Nandyalampet village ,Mydukur mandal , YSR District. In this regard the District Forest Officer , Y.S.R Territorial Division , Kadapa stated these lands are

currently allotted as Compensatory Afforestation (CA) Land for the subject work . The petitioners claim peaceful possession and enjoyment of the respective lands , and the revenue records are in their names as on today. The Hon'ble High Court, A.P issued an order in writ petition No. 6412/2024 , IA No. 1 of 2024 stating that "**In View of the above , there shall be an order of status quo obtaining as on today**". In view of the court case the District Forest Officer , Y.S.R Territorial Division , Kadapa is requesting to kindly arrange another Compensatory Afforestation (CA) Land which is not having legal issues and encroachments etc; for further processing the proposals at the earliest.

Afterwards , this office has requested the District Collector, YSR District to kindly provide alternate Compensatory Afforestation (CA) Land for an extent of 11.03 Ha which is not having legal issues and encroachments etc; . Accordingly the District Collector, YSR District vide reference 5th cited has allotted C.A land in Sy. No. 506/B & 507 of Nandyalampet Village of Mydukur Mandal to an extent of 24.78 Ha for the subject work. Afterwards the DGPS survey was conducted for C.A land under the supervision of forest officials and the DGPS maps of C.A land submitted for Authentication to the Competent Authority of Forest Department. Subsequently , the Competent Authority Prl. Chief Conservator of Forests & Head of Forest Force, Guntur, A.P vide reference 6th cited has Authenticated the DGPS maps of C.A land to an extent of 24.78 Ha .

Further it is submitted that, after obtaining the Authentication of DGPS maps of C.A land , the necessary documents along with C.A land KML file was uploaded in Parivesh Portal . The **Form-A (Part-I): Diversion of Forest Land proposals are herewith submitting through Parivesh Portal for Stage-I Approval .**

Therefore , it is requested the District Forest Officer , Y.S.R Territorial Division , Kadapa to kindly process **Form-A (Part-I): Diversion of Forest Land** proposals for further process.
