- 3) Details of minor bridge and culvert box not enclosed in the proposal. The same should be shown in KML file.
- 4) Gut No.8,9 showing status on 7/12 extract is land diverted to D.P.A.P and Gut No.6 showing status on 7/12 extract is land diverted to Sarpanch Grampanchyat Chikhali. Forest land not seen in 7/12 extract. Clarification and relevant document to be needed.

The above discrepancies should be complied to this office at the earliest.
