Sub:- Proposal for diversion of 23.714 Ha of Forest Land for construction of Pandit Raghunath Murmu Medical College and Hospital in the District of Mayurbhanj under Baripada Forest Division.

In inviting reference to the letter on the subject cited above, I am submitting below point wise compliance and supporting documents for favour of your kind information and necessary action.

- (i) **KML file of the forest area proposed for diversion and also of CA land needs to be furnished.**

Compliance:-KML file of the forest area proposed for diversion and also of CA land is enclosed in shape of CD.

- (ii) **Non- encroachment and non-encumbrance certificate of the CA land duly signed by concerned Tahasildar and DFO needs to be furnished.**

Compliance:-Non- encroachment and non-encumbrance certificate of the CA land signed by the concerned Tahasildar, User Agency and DFO is enclosed as Annexure-I.

- (iii) **In part-II of DP in Column No. 10(i), the CA land is mentioned as Govt. Non- Forest land and in site inspection report in Column 17, it is mentioned as Govt. Forest Land. In both the cases, it should be mentioned as degraded revenue forest land. This should also be mentioned in the Site Specific CA Scheme.**

Compliance:-The Revised Part-II in Column No10(i), the CA land is mentioned as Degraded Revenue Forest Land which is enclosed as Annexure-II and the Revised Site Inspection Report is enclosed as Annexure- III

- (iv) **The CA scheme over 49.952 ha (or 50ha) of degraded revenue forest land has not been prepared basing on one time cost norm. You are requested to prepare the CA scheme as per one time cost norm & submit in 3 sets.**

Compliance:-The CA scheme over 49.952 ha (or 50 ha) of degraded revenue forest land is prepared basing on one time cost norm is enclosed as Annexure-IV (3 sets).
