Sub:- Compensatory Afforestation - YSR District - Mydukur Mandal - Nandyalampet Village - District Forest Officer, YSR (T) Division, Kadapa request to consider to an extent of 101.47 acres out of 221.78 acres, in Sy.No.506-B and Sy.No.507 of Nandyalampet Village, Mydukur Mandal as Compensatory Afforestation land, in order to cater the requisitions of diversion of Forest land for NH-67 & NH-167B projects in the District - Regarding.

I invite your attention to the references cited.

It is to inform that, the Joint Collector has conducted the discussion with the RDO, Badvel and the Tahsildar, Mydukur on 30.07.2024 regarding allotment of CA land in Nandyalampet Village, Mydukur Mandal. During the discussion, the Joint Collector has directed to put up revised Compensatory Afforestation proposals to the District Forest Officer, Kadapa (T) Division, Kadapa for an extent which is not covered by court cases and encroachments in order to cater the requisitions of diversion of Forest land for the important projects in the District.

In this connection, in the reference 10th cited, the Tahsildar, Mydukur has submitted a report stating that, as per the instructions of the District Collector, he has conducted field inspection along with the MRI, Mandal Surveyor, Village Surveyor and concerned Village Revenue Officer over the land in Sy.No.506-B and Sy.No.507 of Nandyalampet Village, Mydukur Mandal in connection with allotment of Government lands to Forest Department on Compensatory Afforestation and enquired into the matter. During the field inspection and enquiry, it is noticed that, the total extent of the land in **Sy.No.506-B is 38.94 acres** and the total extent of the land in **Sy.No.507 is 267.56 acres (Total extent 306.50 acres)**, out of which an extent of **61.50 acres** is covered in three WPs and there are encroachments in an extent of 8.76 acres covered with 3 un-used bore wells and 01 small shed and an extent of **14.46 acres** covered with Mango tress, mixed horticulture crops and one bore well. Hence, an extent of **221.78 acres** is available at present without involvement of court cases and free from encroachments.

Further, it is to inform that, the Tahsildar, Mydukur has reported that, he has identified an extent of 40.28 (LPM) acres in Sy.Nos.2235, 2237, 2238, 2239, 2240, 2241 and 2242 of Nandyalampet Village, Mydukur Mandal for allotment under Compensatory Afforestation as requested by the DGM (T) & Project Director, PIU-Nellore and an extent of **27.07 acres in Sy.No.506-B1**, an extent of **8.88 acres in Sy.No.506-B3**, an LPM extent of **20.83 acres in Sy.No.2183/2 (which is block splitted in Sy.No.507)** and an LPM extent of 5.53 acres in Sy.No.2211 (**which is block splitted in Sy.No.507**) of Nandyalampet Village, Mydukur Mandal, total extent 62.31 (LPM) Acres and there are some trees standing in Sy.No.506/B1 which is free from encroachments and not involved in court cases for allotment of land under Compensatory Afforestation as requested by the E.E(R&B), NH Division, Kadapa.

Therefore, I request you to consider two times of required extent i.e., (47.37x2) 94.74 acres and an additional extent 6.73 acres, total extent 101.47 acres, out of 221.87 acres in Sy.No.506-B and Sy.No.507 of Nandyalampet Village, Mydukur Mandal as Compensatory Afforestation land which is not covered in Court cases and

encroachments as per your request, in order to cater the requisitions of diversion of Forest land for the following important projects in the District.
