The Nodal Officer and Principal Chief Conservator of Forests, (Forest Conservation) Bangalore has directed the undersigned to process the online proposal and submitting the hard copy of the said proposal through the Conservator of Forests, Kanara Circle, Sirsi.


As per the above direction the proposed area has been inspected by me on 08-11-2022 along with Assistant Conservator of Forests, Karwar Sub-division, Karwar, Range Forest officer, Karwar and range staff. The proposed area is middle of the Karwar City and the proposed area is the last piece of valuable forest land left in the Kodibag F.Sy.No. 17A. So it has been consolidated by construction of laterite stone compound wall during 2021-22 for protection. In this area there are already two constructed forest department residential quarters and

one under construction. And also proposed construction of staff quarters complex in this area during 2022-23. The necessary site inspection report has been recorded and enclosed.

The proposed area is Reserve Forest and coming under Eco-class-I. and there are five trees in the proposed area.

Hence it is recommended for rejection of the proposal for diversion of 0.10 ha. forest land. The necessary proposal is submitted in five sets along with duly filled Part-II for kind perusal and further needful action.
