Following precautions to be taken while laying Water pipe crossing on Railway land:-

1-The work shall be completed within five days after starting the work, else extra amount will be charged as detention charges as per report of Railway Engineers at site.

2-Before starting the work on railway land ADEN/BNDA is to be contacted and the work should be carried out under the supervision of SSE/PW & S&T and Electrical staff concerned.

3-Water pipe crossing casing shall be laid up to railway boundary on either side of the railway track.

4- Water pipe crossing should be laid through Trenchless pipe pushing method only, the casing pipe will be inserted simultaneously with boring to keep formation supported all the time to prevent any settlement of track, as per attached approved drawing (DRM/W/JHS/SK/2022-WL-14). Work should completed in all respect within six months.

All other formalities shall be ensured as per direction of railway Engineer Incharge subject to Railway rules terms and condition etc., amended time to time & mentioned in Drg. & RDSO guide lines.
