I wish to inform the following with reference to the letter in reference 10th cited, wherein the Assistant Inspector General of Forest, Regional office, MOEF&CC, Chennai has stated that two proposals submitted by Chief Engineer (H), Metro for diversion of forest land may be withdrawn and to submit fresh proposal combining the two proposals and avoid splitting.

i) Land Acquisition for the work of Formation of Tambaram Eastern by pass road at Km 0/0 - 9/300 has been sanctioned vide ref.1st cited by Govt. of Tamilnadu on 23.09.2004. The stretch from Km from 8/000-9/300 falls in Vandalur Reserve Forest area to an extent of 4.46 Ha. Hence proposal for diversion of forest land of 4.46 Ha in

- Vandalur RF was uploaded online in **Parivesh Portal** vide online proposal No FP/TN/Road 148656/2021 on 22.10.2021.
- ii) The work of Construction of ROB in lieu of LC-32 at Perungalathur in between Tambaram and Vandalur Railway stations has been sanctioned vide ref 2<sup>nd</sup> cited by the Government of Tamilnadu on 01.12.2010. For this work, forest land to an extent of 0.95472 Ha in Vandalur Reserve Forest land is required. Hence proposal for diversion of forest land of 0.95472 Ha in Vandalur RF was uploaded online in **Parivesh Portal** vide online proposal No FP/TN/Road/151930/2022 on 02.2.2022.

The requirement of Forest land for the above two works were assessed at different dates and accordingly the proposal for diversion of forest land was submitted to Forest department for approval in Parivesh Portal.

From the above table, it may be inferred that though the combined area of forest land is more than 5 Ha for the two works, the works have been sanctioned at different dates and the proposal for diversion of forest land has also been initiated at different dates depending upon the execution stage of the above schemes. Hence, it is submitted that there is no artificial split up of forest land diversion proposal.

Considering the above facts, I request that necessary permission may be obtained from Additional Chief Secretary to Government, Environment, Climate Change and Forest Department for the proposal for diversion of forest land for the above two works as submitted earlier in order to expedite both Bypass and ROB works independently.





As the DPR work could not be finalised due to frequent alterations made by Railways in the combined GAD and delay in obtaining concurrence of NHAI as the rotary and major

5. The Chief Engineer (Metro) Highways Department has further stated that the land acquisition for the above work is in progress and an expenditure of Rs.24.29 crore has been incurred so far. Further additional compensation towards new land acquisition Act has to be paid. Land acquisition was done only for the ROB in lieu of LC 32. No separate land acquisition is required for pedestrian subway in lieu of LC 33 and hence no expenditure was incurred for the pedestrian subway in lieu of LC 33. The deletion of pedestrian subway in lieu of LC 33 from the proposal does not have any impact in the Land acquisition completed so far and has sent a modified RAS proposal for Rs.206.83 crores as detailed below with change in nomenclature with provisions already finalized by the RAS committee excluding Pedestrian Subway (in lieu of L.C.33) for the work of "Construction of a ROB in lieu of LC No.32 in between Tambaram–Vandalur Railway stations near Perungalathur" instead of "Construction of ROB in lieu of L.C.No.32 and 33 in between Tambaram and Vandalur Railway stations near Perungalathur" for which Revised Administrative Sanction has already been recommended for Rs.214.83 crores.

Survey of India topo sheet of Vandalur RF and surveyed sketch of the proposed CA area in geo-referenced map. Site suitability certificate of the CA area have also been furnished by the District Forest Officer.

- x) In the site inspection report and recommendation of the proposal, the District Forest Officer has stated the following.
- a) This proposal is for diversion of 0.95476 Ha of forest land in Vandalur RF of Chennai Division for construction of Road over Bridge in lieu of LC No. 32 in between the Tambaram and Vandalur Railway Stations near Perungalathur has been inspected on 03.11.2022.

The user agency has not yet started any work in the Reserved Forest area so far and there is no encroachment in the proposed area. The forest land required for the project is not the part of National Park/Wildlife sanctuary. No rare/endangered/unique species of flora and fauna in the Reserved Forest. Forest type is Southern Dry Mixed Deciduous Forest.

There is no right of way notification for this proposal. There are 204 number of spontaneous trees in this diversion proposal. After construction of Road over Bridge need of level crossing at this location would be eliminated, thus ensuring a smooth traffic movement on the National Highways and hence recommended.

In the EDS reply, the District Forest Officer has reported that, the proposed area of diversion for construction of ROB ends at the centre of the Reserved Forests and then the road work continued with Forest Clearance proposal No. FP/TN/Road/148656/2021 in the name of Eastern Bye pass road by the Highways Department CMDP-Division-I, Alandhur.

This forest area diversion proposal has already forwarded to the District Forest Officer, Chennai Division on 05.05.2023 for processing and as per the time line details, the proposal is pending with the District Forest Officer, Chennai Division due to EDS raised by the Chief Conservator of Forests, Chennai Circle on 03.07.2023.

Hon'ble Supreme Court of India in judgment dated 11.01.2023 in LA Nos 168328/2022 and 168313/2022 and 1.A Nos. 191583/2022, have directed that the order requiring permission of the Court for felling of trees in all forest areas in respect of any road projects initiated by NHAI or any other instrumentality of the State, which involves cutting of up to 500 trees is recalled subject to certain conditions and among others, the projects would be permitted only after the concurrence of the Integrated Regional Office (IRO), Chennai.

Hence concurrence of the Integrated Regional Office, MoEF&CC. Chennai is required for this project.

- 7) Based on the recommendation made by the District Forest Officer, Chennai Division and Chief Conservator of Forests, Chennai Circle, proposal received for diversion of 0.95472 ha of forest land in Vandalur RF for construction of Road over Bridge in lieu of LC No. 32 in between Tambaram and Vandalur Railway Station near Perungalathur in Chengalpattu District seeking approval under Section 2 of Forest (Conservation) Act, 1980 by the Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-II, Chennai may be considered and concurrence may be obtained from the Government of India for felling of spontaneous trees in the project area and the following conditions may be recommended for imposition of the project.
  - i) The legal status of the diverted forest land remains unchanged.
- ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.



Further the project proponent has agreed to pay the Net Present Value of the forest land and also given an undertaking to bear the cost to be incurred towards felling of standing trees 285 Nos in which 117 are spontaneous and 168 are planted trees and its transportation during the formation of Tambaram Eastern Bypass road under the said project as well as cost involved towards compensatory afforestation.
- d) In the EDS reply, the District Forest Officer has reported that, the proposed area of diversion for formation of eastern bypass road starting point links with the end portion of Road over Bridge (RoB) proposed by the Highways Department vide proposal No. FP/TN/Road/151930/2022 and the end portion of the proposed road connects with the newly formed bypass road outside the Reserve Forest in Alapakkam village. The road which is already existing and passing through the Reserve Forest is a right of way.
- e) For raising of compensatory afforestation in lieu of diversion of 4,46 ha of forest land in Vandalur RF for formation of Tambaram Eastern Bypass road, the user

agency has identified 8.92 ha of non-forest land in SF No. 96/1 of Vedhanarayanapuram in Chengalpattu District. The District Forest Officer, Chengalpattu Division has reported that the land is already having vegetation with forest like characteristics and hence compensatory afforestation could not be taken up in the said land. Hence the District Forest Officer, Chennai Division has selected 8.92 ha of degraded forest land in Gudalur RF to carry out compensatory afforestation work.

- f) Taking into consideration of the above, the District Forest Officer, Chennai Division gas recommended the proposal furnished for diversion of 4.46 ha of forest area in Vandalur RF.
- 3) The Chief Conservator of Forests, Chennai Circle has inspected the area on 15.06.2023 and endorsed the details provided by the District Forest Officer and recommended the proposal. Forest clearance proposal forwarded through web portal on 10.07.2023 and EDS query replied on 22.07.2023.
- 4) The User Agency has requested forest area diversion for a period of 99 years. The District Forest Officer, Chennai Division has recommended the project for 30 year period and the Chief Conservator of Forests, Chennai Circle has recommended the diversion of forest area for a period of 20 years.

Forest area diversion proposals for road works are permanent nature and hence recommended for a period of 50 years.

hectare in each case for non-forestry purposes under the Forest (Conservation) Act, 1980, for creation of critical development and security related infrastructure of Government Departments under the general approval of Section 2 of Forest (Conservation) Act, 1980 guidelines. Construction and widening of road is one of the work allowed under general approval list. Diversion of 0.95472 ha of forest land has been requested in Vandalur RF for construction of Road over Bridge in lieu of LC No. 32 in between Tambaram and Vandalur Railway Station near Perungalathur in Chengalpattu District. Construction of Rail Over Bridge in the road portion may be treated as part of Road Project.

Since the diversion of forest area is above one ha, approval from Government of India is required.

Further, this project involves felling of 117 number of spontaneous trees. Hon'ble Supreme Court of India judgment dated 11.01.2023 in I.A Nos 168328/2022 and 168313/2022 and I.A Nos. 191583/2022, have directed that the order requiring permission of the Court for felling of trees in all forest areas in respect of any road projects initiated by NHAI or any other instrumentality of the State, which involves cutting of up to 500 trees is recalled subject to certain conditions among others, the projects would be permitted only after the concurrence of the Integrated Regional Office (IRO), Chennai.

Hence concurrence of the Integrated Regional Office, Chennai is required for this project.

- 6) Based on the recommendation made by the District Forest Officer, Chennai Division and Chief Conservator of Forests, Chennai Circle, proposal received for diversion of 4.46 ha of forest land in Vandalur RF for formation of Tambaram Eastern Bypass road branching from km 17/4 of Malmalong bridge-Irumbuliyur road from Rajakilpakkam via Agaramthen road towards Perungalathur at km 0/0-9/300 in Chengalpattu District seeking approval under Section 2 of Forest (Conservation) Act, 1980 by the Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-I, Chennai may be furnished for consideration of the Government and to obtain concurrence from the Government of India and the following conditions may be recommended for imposition of the project.
  - i) The legal status of the diverted forest land remains unchanged.
- ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.
- iii) The user agency has to pay the cost towards compensatory afforestation scheme over an extent of 8.92 ha of degraded forest area as per the Compensatory afforestation scheme including maintenance for a period of 10 years.
- iv) The User Agency has to pay the Net Present Value of proposed forests diversion area which will be fixed as per the guidelines of Hon'ble Supreme Court of India/Government of India.
- v) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.

- vi) Amount of Compensatory afforestation scheme, Net Present Value of diverted forest area under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/)
- vii) The user agency has to deposit the amount required for felling and transport of trees to be felled in the project area with the District Forest Officer concerned.
- viii) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- ix) The total forest area utilized for the project shall not exceeds 4.46 ha in Vandalur RF.
- x) The forest land proposed to be diverted shall under any circumstances be transferred to any other agencies/ department or person without prior approval.
- xi) Period of lease can be fifty (50) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.
- 7) The proposal is sent herewith duly recommended by the Additional Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer of Forest (Conservation) Act, 1980 of the State of Tamil Nadu.
- 8) I request that the proposal may be considered and approval may be obtained from the Government of India for diversion of 4.46 ha of forest land in Vandalur RF for formation of Tambaram Eastern Bypass road branching from km 17/4 of Malmalong bridge-Irumbuliyur road from Rajakilpakkam via Agaramthen road towards Perungalathur at km 0/0-9/300 in Chengalpattu District in favour of Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-I, Chennai for a period of 50 years.



With reference to the subject and reference above, I am directed to inform that, upon preliminary examination of the subject proposal, it is seen that the UA, i.e. Chief Engineer, Metro, Highways Department submitted two proposals i.e. FP/TN/ROAD/151930/2022 for 0.95472 ha and FP/TN/ROAD/148656/2021 for 4.46 ha and noted that above mentioned two proposals are in same stretch and continuous in alignment. The State Government vide letter dated 03.08.2023 requested the RO Chennai to convey approval for felling of 204 spontaneous trees under proposal No FP/TN/ROAD/151930/2022 involves diversion 0.95472 ha and whereas submitted the subject proposal to this office for approval under FCA, 1980;

In view of the above, it is to inform that, splitting of same stretch of road in to smaller area shall not be done and especially for linear proposals, proposal shall be submitted for its entirety. By splitting of proposals, competent authority to decide on such proposal will also change as per the delegation of powers and such artificial splitting is not permissible.

Considering the above facts, it is requested that State Government may inform all stake holders including forest department Officials not to

split the proposals in future. Further, the UA i.e. Chief Engineer, Metro, Highways Department may be directed to withdraw the above two proposals from the PARIVESH and to submit a fresh proposal for the revised area by combining **0.95472** ha + **4.46** ha = 5.41472 ha.

As the combined area will be more than 5 ha, the revised proposal needs to be processed through Project Screening Committee (PSC) as per the provision of FC rules 2022. Further, it is also noticed that, the proposed CA scheme is not as per the provision of FC rules 2022, hence, Nodal Officer may be advised to re-examine the CA scheme and to submit appropriate CA scheme along with the said revised proposal.

With reference to the letter under reference 9th cited, the following is submitted for kind consideration.

The Scheme proposed under diversion of forest land of 4.46 Ha in Vandalur RF vide online proposal No FP/TN/Road 148656/2021 is pertaining to new formation of Tambaram Eastern ByePass which has been sanctioned vide ref.1st cited by Govt. of Tamilnadu on 25.1.2004 under State Government 2004-2005, Traffic Improvement Scheme.

The Scheme proposed for felling of spontaneous trees permission sent by the State Government vide ref. 8th cited is pertaining to Construction of ROB in LC-32 in between Tambaram and Vadalur Railway stations which has been sanctioned vide ref 2nd cited by the Government of Tamilnadu on year 2010 under RWP (Railway Work Program) Program for the year 2010-2013.

The diversion of Forest land for the above two cases arrives at different stages. Accordingly the proposal for diversion of forest land for Eastern Bypass was submitted to Forest department for approval in Parivesh Portal on 22.10.2021. Whereas the diversion of Forest land proposal for ROB LC 32 at Perungalathur was submitted to Forest for approval in Parivesh Portal on 02.2.2022 by the user Agency, Highways Department.

From the above table, it may be inferred that though the forest land combined area is more than 5 Ha, the Scheme for carrying out the project have been sanctioned at different dates and the proposal for diversion of forest land has also been initiated at different dates depending upon the execution stage of the above schemes. Hence, it is submitted that there is no artificial split up of forest land diversion proposal has been done by the user agency.

Considering the above facts, it is requested that necessary permission may be obtained from Additional Chief Secretary to Government, Environment, Chimate Change and Forest Department in order to expedite both Road and ROB scheme works independently.
