Dandeli** (User Agency) for raising of compensatory afforestation (CA),, in forest land diversion proposal No.FP/KA/IND/26920/2017 regarding clearance of Effluent Treatment Plant-II of West Coast Paper Mills, Ltd. Dandeli for diversion of forest land in **Kerwad Village Sy. No.22 of Haliyal Division(s)** has been inspected by me on dated **08-10-2023**.
2. The said non-forest CA land parcel(s) is/are suitable for Development of Wild Life Habitat instead of raising compensatory afforestation in accordance with Government of India FC Guidelines F. No. 11-423/2011-FC dated 08-11-2017 read with general FC Guidelines, and in case of Private Party User Agency, further as per Government of Karnataka Order No.FEE 82 FLL/2016 dated 31-08-2016.
3. It is further reported that the said land parcel(s) has natural growth of Anjan, Kunjan, Kindal, Nandi and Cashew etc and comes under Evergreen and Semi evergreen forests thereafter planting is not necessary therein. Remaining seedlings are proposed to be planted in Degraded Forest Land [Table 2] in consonance with the working plan prescriptions.

In reference to the above, vide letter reference no.1 M/s West Coast Paper Mills Ltd. Dandeli have requested to issue a Suitability Certificate to acquire the land situated at Amagaon village into departmental possession. The details of which are as follows:

The Range Forest Officer, Wildlife Range, Bhimgad has inspected the said land on 26-02-2022 under Reference-2 and the Assistant Conservator of Forests, Sub-Division, Khanapur has inspected the said land and submitted report on 28-02-2022 under reference (3) respectively.

The details are as below :

1) The Amagaon village R.S. No.6/7 are Malki lands as per the RTC's of the Revenue Department.

2) The land is bounded by Sy No.7 is to the East, Sy. No.8 to the West, R.S.No.6/6 to North and to the South is RS No. 6/8.

3) The proposed RS No. 6/7 is having the Jambittige Soil quality.

4) In the said R.S.Number there is a dense vegetation mainly of Anjana, Kunjana, Kindala, Matti, Nandi species and there is grassland on the vacant land and cashew trees are planted.

5) As the said R.S. Number is located in the middle of the forest area, it is very useful for increasing the habitat of wild animals and increasing their progeny.

6) It is suitable to grow medicinal saplings as afforestation work in the said area.

7) There are about 20% grass tussocks in the said R.S.Number and jungle trees in the remaining area.

The reports of Range Forest Officer, Bhimgad and Assistant Conservator of Forests, Subdivision, Khanapur are justifiable.

Further, the said proposed area is surrounded by forest land and falls under the Bhimgad Wildlife Zone. If the said area is handed over to the department from the user agency, the forest area will increase, and the wildlife habitat will increase along with the wealth development. Before handing over the proposed Malki land, a joint survey by (Revenue and Forest Department) should be conducted and the said land should be cleared of any encumbrance and handed over to the Department.


