Subject: Diversion of 39.5449 ha Forest land for four laning of Tumakuru-Shimoga Section of NH-206, chainage km 12+310 and km 217+000-reg.

With respect to above subject and reference (1) NHAI, PIU (Shimoga) Chitradurga had submitted online proposal for diversion of 39.5449 ha of forest land for improvement of National Highway 206 between Tumkur and Shimoga (Section - I) on 21.12.2017.

The online proposal was re-submitted with a revised total forest land of 40.2625 Ha on 03.10.2018.

The proposal was verified by respective RFOs of both Gubbi and Tiptur and subsequent to verification, a letter vide reference (2) was received from office of DCF, Tumkur on the addition and deletion of forest area pertaining to forest survey and non-forest survey numbers respectively, asking NHAI, PIU to revise the online proposal accordingly.

The proposal is updated as per the comments received from Office of DCF, Tumkur as follows.
