Subject: Diversion of 39.5449 ha Forest land for four laning of Tumakuru-Shimoga Section of NH-206, chainage km 12+310 and km 217+000-reg.

With respect to above subject and reference (1) NHAI, PIU (Shimoga) Chitradurga had submitted online proposal for diversion of 39.5449 ha of forest land for improvement of National Highway 206 between Tumkur and Shimoga (Section - I) on 21.12.2017.

The online proposal was re-submitted with a revised total forest land of 40,2625 Ha on 03.10.2018.

The proposal was verified by respective RFOs of both Lakkavalli and Bhadravati and subsequent to verification, a letter vide reference (2 & 3) was received from office of DCF, Bhadravati on the addition of area pertaining to additional forest survey numbers asking NHAI, PIU (Shimoga) Chitradurga to revise the online proposal accordingly.
