Crystal Minerals upto 10.07.2021.</p> <p>Later vide ref dated 13.04.2018, the permission has been accorded for inclusion of Feldspar mineral as additional mineral in the existing quarry lease held by crystal minerals and to execute the quarry lease deed within a period of 60 days from the date of order. further, an extension of (30) days has been granted on 15.12.2020 for execution of quarry lease deed by the DMG.</p> <p>Presently, the extension of mining lease for Quartz and Feldspar is under process at DMG for granting permission to the crystal minerals.</p> <p>Now, the proposal is submitted for approach road to reach the mining lease site for transporting the minerals.</p> <p>Previously, neighboring land owner has given permission for road access from his farm land. Later, the neighbor has sold the farm land to other party. Now the existing party is obstructing for accessing the path to reach the mining lease.</p> <p>The Forest land is situated beside the farm land, on enquiry with the forest officials, the Forest department has instructed us to submit the application for diversion of road proposal under F(c)Act, 1980. As there is no other option for us to reach the mining lease site and to avoid</p>
