THIS DEED OF TRUST made and executed on this 21th day of July, year 2015, by and between

Jacky D'silva, son of Francis D'silva, aged about 59 years, and currently residing at Near Ration Shop, Bangarappa Nagar, Shirwad, Karwar. herein after referred to as the "SETTLOR," having been appointed as such by the Karwar Congregation of Jehovah's Witnesses Karwar, Karnataka (hereinafter called the "Congregation") and

1) Samson Ruzario, son of Louis Ruzario, aged about 50 years, and currently residing at Ruzario Compound, Nadangadda, Karwar - 581304.

2) Benjamin Ruzario, son of Louis Ruzario, aged about 55 years, and currently residing at "BENAN VILLA" Vasant Nagar, Devliwada, Karwar - 581304.

3) Joseph Ruzario, son of Inas Ruzario, aged about 68 years, and currently residing at Ruzario Compound, Nandangadda, Karwar - 581304.

4) Jacky D'silva, son of Francis D'silva, aged about 59 years, and currently residing at Near Ration Shop, Bangarappa Nagar, Shirwad, Karwar.

herein after referred to as the "TRUSTEES," which expression shall be deemed to include their successors in office. All the above trustees or their successors in office, as the case may be, shall be collectively called the "Board of Trustees" and individually called Trustee.

WHEREAS the Settlor named above, having been appointed by and acting solely and exclusively at the direction of, on behalf of, and for the benefit of the Congregation, has deemed it appropriate to establish this Trust for the purposes set forth herein.

AND WHEREAS each of the Trustees has agreed to act as a Trustee of this Trust.

AND WHEREAS all activities of the Trust shall be carried out with a view to benefit the Congregation in particular, without any profit motive and in accordance with the provisions of the Income-tax Act, 1961, as amended from time to time (the "Act"), and the Trust shall be registered and, if it is granted income tax exemption, no amendment to the Trust Deed shall be carried out without the approval of the competent authorities as designated in the Act.

AND WHEREAS the Trust is created for religious purposes and is hereby expressly declared to be a religious Trust, and all the provisions of this Trust Deed are to be construed accordingly. If any of the objects or provisions of this Trust are inconsistent with the character of the Trust as a religious one for the purposes of the Act or any other purpose, then such object or provision will stand omitted or modified so as to be consistent with such purpose and the Act.

NOW THIS TRUST DEED WITNESSES AS FOLLOWS:

1. **NAME:** The name of the Trust shall be “**Karwar Congregation of Jehovah’s Witnesses Religious Trust**” (hereinafter referred to as the “Trust”)


2. **PLACE:** The principal office of the Trust shall be situated at **Dr.Ambedkar Road, Ruzario Compound, Nadangadda, Karwar, Karnataka - 581304**, or such other place as the Trustees may from time to time determine.

3. **SETTLEMENT:** The Settlor named above has donated the sum of Rs 1000 and the Board of Trustees hereby duly accepts and acknowledges receipt thereof on behalf of the Trust and hereafter stand possessed of Trust property (which term shall include donations, gifts, contributions, both in India and from abroad, and all investments in cash or kind, movable and immovable property, including tangible and intangible assets which may from time to time be converted, exchanged, altered, varied) in trust for the Congregation in harmony with the objects of the Trust herein set out and subject to the terms and conditions of the Trust contained herein.

4. **OBJECTS:** The primary objects of the Trust are religious in harmony with the principles found in the Holy Bible, for the benefit of Jehovah’s Witnesses and the public at large who are interested in the beliefs of Jehovah’s Witnesses irrespective of caste, creed, religion, or sex throughout the territory of India. Specifically, the Trust’s objects are:

- A. To assist the Congregation to fulfill the Biblical commission outlined in the Gospel of Matthew, chapter 24, verse 14 and chapter 28, verses 19, 20; it is the local community of believers that unitedly proclaim the Word of God, especially the message about the name, word, and sovereignty of the Almighty God JEHOVAH that it contains, and to proclaim the gospel of God’s Kingdom under the rule of Christ Jesus; members of the Congregation, under the direction of the body of elders, assist one another materially and spiritually so as to enable them to “hold fast the public declaration of [their] hope without wavering,” to “consider one another to incite to love and fine works,” and to encourage “one another, and all the more so as [they] behold the day drawing near.”—Hebrews 10:23-25.
- B. To obtain and maintain a place or places of public worship for Jehovah’s Witnesses and to promote and support other organizations and trusts with similar objects throughout the territory of India.
- C. To support the Congregation and its members in their effort to advance and promote the study of the Bible based on the beliefs as approved and directed by the ecclesiastical Governing Body of Jehovah’s Witnesses.




- D. To contribute to and improve the spiritual, moral, and intellectual faculties of men, women and children.
- E. To support the Congregation in holding and conducting meetings for worship that include discourses for the moral, social, and spiritual advancement of the public in general and "Jehovah's Witnesses" in particular by conducting public and private meetings that include Bible-based instruction to assist people to improve in various aspects of their lives including public speaking, teaching, reading, speaking English and Indian languages, including Indian sign language, and other subjects.
- F. To support and facilitate members of the Congregation to distribute, without cost, religious publications in print or electronic or any other media used to distribute publications including through the Internet.
- G. To support the India branch office of Jehovah's Witnesses in efforts to provide humanitarian assistance to the victims of natural and man-made disasters. To undertake any other activities incidental to the above activities but which are not inconsistent with the above objects.

5. FUNDS AND ASSETS: The Trust may accept donations, grants, subscriptions, aids or contributions from any person, government, local authorities or any other charitable institutions including foreign nationals and entities, in cash or in kind including immovable property. All monies shall be deposited by the Trustees in bank/s, and the Trustees may transfer funds to other trusts having similar objects as the Board of Trustees may decide from time to time. Such deposits and bank accounts shall be in the name of the Trust. The Trustees shall manage the Trust fund and assets thereof in a responsible and prudent manner. The investment of funds of the Trust will be in accordance with the provisions of Section 13(1)(d) read with Section 11(5) of the Income Tax Act, 1961, as amended from time to time. The Trustees shall apply such receipts to the objects of the Trust. Any receipts for a specific purpose or object shall be treated as such and separate funds shall be created and maintained accordingly. If foreign contributions or donations are received, they shall be accounted separately and held in separate bank account/s, if required by law. The Trustees shall receive and hold the receipts or income of the Trust on behalf and for the benefit of the beneficiaries under the Trust.

6. ACCOUNTS AND AUDIT: The Board of Trustees shall keep proper books of account of all the assets, receipts, liabilities, income and expenditure of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March in accordance with the laws, rules and regulations in existence from time to time with respect to a religious Trust.

The accounts of every year shall be audited by a chartered accountant or by another competent person, who shall be appointed for that purpose by the Board of Trustees, and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year. The minutes of such annual meeting shall be recorded in the minute book. If legally required, the Trust shall file annual returns under section 139 (4A) of the Income tax Act along with a report of the auditor in legally acceptable form, if and when the gross receipts of the trust exceed the tax exempt limit set by the government from time to time for a charitable trust.

7. TRUSTEES: NUMBER, QUALIFICATIONS, AND OTHER PROVISIONS: The number of the Trustees shall not be less than three but not more than nine. The Trustees in office may, from time to time, appoint other Trustees or successor Trustees. The Trustees shall elect one from among their number as Chairman of the Board of Trustees

In order to qualify to serve as a Trustee, a person must be serving in a congregation of Jehovah's Witnesses as an elder or ministerial servant duly appointed according to the practices and procedures established by the ecclesiastical Governing Body of Jehovah's Witnesses. A Trustee shall automatically cease to be a Trustee: (a) when he is not an elder or ministerial servant in a congregation of Jehovah's Witnesses; (b) when he resigns his office by notice in writing to the Board of Trustees; (c) dies; or (d) is removed as a Trustee by the Board; reasons for such removal include, but are not limited to, that the trustee (i) is bankrupt, (ii) is of unsound mind, (iii) is absent from his duties as Trustee for six months without permission of the other Trustees, and (iv) is directly or indirectly interested in any contract with the Trust.

Any of the Trustees may retire on giving one month's notice in writing to the Board of Trustees. If any Trustee dies or retires or becomes incapable or unfit to act and if at any time the total number of the Board of Trustees is less than three, then the continuing or surviving Trustee/s shall appoint a successor Trustee in accordance with the express provisions as to qualifications as stated in this item 7.

In case of any irreconcilable difference between the Trustees they shall seek the written directions of the ecclesiastical Branch Committee of the India Branch of Jehovah's Witnesses, or any other entity designated by the ecclesiastical Governing Body of Jehovah's Witnesses, and such written directions shall prevail.

8. POWERS: Subject to any other provision of this Trust Deed and the legal regulations in force at the time, the Board of Trustees shall have the power to manage all the assets and/or properties of the Trust. These powers shall include but not be limited to the following:

- A. To open, close, maintain, and operate bank account/s, deposit the funds of the Trust in bank or transfer funds to be held by such other trusts having similar objects, and purchase movable and immovable properties;

- B. To acquire, buy, sell, alter, vary, transpose, exchange or otherwise dispose or alienate the Trust properties or any funds for the purpose of achieving the object or objects of the Trust;
- C. To pledge or mortgage the Trust properties for raising funds to achieve the object or objects of the Trust;
- D. To pay all charges, impositions, and other outgoings payable in respect of the Trust properties and also to pay all cost of the incidental to the administration and management of the Trust properties;
- E. To file suit on behalf of the Trust and all or any of the beneficiaries, to defend suits filed against the Trust and all or any of the beneficiaries, and to take and defend all actions, proceedings, and disputes affecting the Trust properties.
- F. To accept for the objects of the Trust any gift, donation, or contribution in cash or in kind from any one including, as may be permitted by law, foreign individuals and entities;
- G. To employ, appoint, and seek opinions and services of lawyers and/or chartered accountants as and when required;
- H. To nominate their representatives for any of the aforesaid purposes;
- I. To designate one of the Trustees as the Managing Trustee;
- J. Upon a decision of at least two-thirds (2/3) of the Trustees on the Board of Trustees, to merge the Trust with any other trust having substantially the same purposes as this Trust.

9. GENERAL MEETINGS: The Board of Trustees shall hold general meetings if deemed necessary by the Trustees and one annual meeting within 180 days of the close of the financial year at which meeting the accounts of the Trust, duly certified by the auditor(s) appointed by the Board of Trustees, shall be presented, the auditor for the fiscal year be elected and any other matter be considered and the necessary resolutions be passed.

Any Trustee may convene an extraordinary general meeting of the Board of Trustees by serving notice in writing together with an agenda for the meeting seven (7) days in advance to the other Trustees. The Managing Trustee may call an extraordinary general meeting of the Board of Trustees by providing notice in writing together with an agenda for the meeting three (3) days in advance.

No business shall be transacted at any general meeting unless a quorum of Trustees is present at the time when the meeting proceeds to business. video conference and telephone tie-in shall deem to constitute presence in person at such meeting. The presence of two thirds (2/3) of the Trustees shall constitute a quorum. At any general meeting a resolution put to the vote of a meeting shall be decided by a show of hands.

If a quorum is not present at, or within half an hour from, the time appointed for the meeting, the meeting, if convened upon the requisition of a Trustee, shall be dissolved; and in any other case, it shall stand adjourned to such day, and at such time and place, as the Trustees present determine, or, if no determination is made by the Trustees, to the same day in the next week at the same time and place; and, if at the adjourned meeting a quorum is not present at or within half an hour from the time appointed for the meeting, the Trustees present, being not less than three, shall be a quorum; and if three members are not present, then the meeting shall be dissolved.

The Managing Trustee who will act as the Chairman shall preside at every general meeting of the Board of Trustees, but, if he is not present within 15 minutes after the time appointed for the holding of the meeting, or if he is unwilling to act, then the remaining Trustees present, being a quorum, shall elect one of the Trustees to be chairman of the meeting.

10. BANKING ACCOUNT/S: All income, receipts, subscriptions, and pecuniary donations for the general purposes of the Trust and the income, investments, and all other moneys from time to time forming part of the general revenue of the Trust shall be paid into banking account/s with any scheduled bank/s for the purpose of the Trust. The Bank accounts shall be operated by any two or more Trustees jointly as approved by the Board of Trustees.

11. AMENDMENTS: If legally required, the competent Income Tax authority will be notified of any amendment to the Trust Deed, after a majority of Trustees vote in favour of such an amendment at a special meeting of the Board of Trustees.

If any of the objects or any other provision of the Trust is inconsistent with the character of the Trust as a public religious trust, either under the provisions of law regulating public religious trusts or rules under direct laws relating to exemptions from such public religious trusts, now or as maybe amended from time to time, such objects or provision will be treated as *non est* in the Trust Deed and will stand omitted or modified so as to be consistent with such laws.

12. TRUST IRREVOCABLE: This Trust is irrevocable.

13. DISSOLUTION: If (a) the Congregation ceases to exist pursuant to the practices and procedures established by the ecclesiastical Governing Body of Jehovah's Witnesses or (b) the Trust is unable to function for any reason and, in either case, if any Trust assets are remaining, then the same shall not be paid to or distributed among the Trustees, but the same shall be transferred to one or more trust/s or society/ies whose objects are similar to those of this Trust and whose trust deed or constitution prohibits the distribution






